## **Authority**

ORS 540.570 to 540.580 establishes the process in which a district may submit a request to transfer a water right within district boundaries. OAR Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

## **Applicant**

## **Findings of Fact**

- 1. On May 8, 2017, Westland Irrigation District (WID) filed a district transfer application to permanently change the place of use under Certificates 76715, 76799, 79439, 76727, 76737, and 76752. The Department assigned the application number T-12662.
- 2. Notice of the District Permanent Transfer Application was published on May 16, 2017, pursuant to ORS 540.580 and OAR 690-385-4400. No comments were filed in response to the notice.
- 3. The US Bureau of Reclamation was notified of the transfer application on May 16, 2017; no comments were received within 60 days of the notification.
- 4. On June 15, 2017, WID submitted additional information pertaining to Certificate 76737 to include in the application.
- 5. On December 12, 2017, WID submitted corrections/amendments to their application and maps.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Within 20 days after this final order is issued (i.e., mailing date), the district or any protestant may file with the commission exceptions to the final order. The commission shall issue an order granting or denying the exceptions within 30 days after receiving the exceptions. ORS 540.580(10).

- 6. On February 26, 2018, the Department issued a Final Order approving Transfer T-12662, recorded at Special Order Volume 107, Pages 721-729.
- 7. This order is issued to correct an error and supersedes the Final Order recorded at Special Order Volume 107, Pages 721-729. The applicant requested to transfer 7.8 acres from authorized lands on Certificate 76799 for irrigation located in the SE1/4 SE1/4 of Township 3 North, Range 28 East, Section 5 to new proposed lands. However, within that 7.8 acre parcel, 2.8 acres had already been transferred off under Transfer T-9843 (Special Order Volume 63, Pages 362-368), thus the 2.8 acres was not available as authorized lands for transfer under T-12662. The number of acres on Certificate 76799 involved in Transfer T-12662 has been corrected from a total of 170.1 acres to a total of 167.3 acres. The corrections to the authorized and proposed places of use are show in **bold** in Findings of Facts 10 and 11, below. On September 9, 2018, at the Departments request, the applicant submitted a corrected "ON" map for Transfer T-12662 showing the locations of the correction made in Finding of Fact 11.
- 8. The portion of the first right to be transferred is as follows:

Limit/Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) from March 1 to November 1 and subject to the limitations of paragraph 32 of the Umatilla River Decree for each acre irrigated during the irrigation season of each year.

All the authorized and proposed places of use in this transfer application are layered with Water Right Permit S-55061 which is for use of water from the Columbia River, tributary to the Pacific Ocean. Permit S-55061 has a condition (No. 2, page 32) that states if water authorized under the permit is used for supplemental irrigation, then the pre-existing primary rights for the same place of use cannot be transferred to another place of use or the character of use changed. As required under permit condition No. 16.A and 16.B. all irrigation activity under Permit S-55061 must be mapped by quarter-quarter and reported to the Department prior to February 15 of each irrigation season.

However, the permit holder has not provided any maps or records to indicate an intent to irrigate lands authorized under Permit S-55061 involved in this transfer as described in the above Findings of Facts 5 through 8. Therefore, the Department finds permit condition No. 2 does not apply to the lands involved in this transfer.

- 21. The Department finds that the district permanent transfer application satisfies the criteria of OAR 690-385-4000 and contains the information required under OAR 690-385-4200 and includes maps meeting the requirements of OAR 690-385-4300.
- 22. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
- 23. The proposed change in place of use will not result in enlargement of the rights.
- 24. The proposed change in place of use will not result in injury to other water rights.

#### **Conclusions of Law**

The proposed changes in place of use as proposed in Transfer Application T-12662 satisfy the requirements of ORS 540.574(3) and 540.580.

### Now, therefore, it is ORDERED:

- 1. The order entered at Special Order Volume 107, Pages 721 to 729 is withdrawn and of no further force and effect and is superseded by this order.
- 2. The proposed changes in place of use to the water rights evidenced by Certificates 76715, 76799, 79439, 76727, 76737, and 76752 are approved.
- 3. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificates 76715, 76799, 79439, 76727, 76737, and 76752 and any related decree.
- 4. The former places of use shall no longer be irrigated as part of these water rights.

- 5. The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.
- 6. Water Right Certificates 76727, 76737, and 76752 are hereby cancelled. A new certificate will be issued describing that portion of Water Right Certificate 76727 NOT modified by this transfer.
- 7. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2019**. A Claim of Beneficial Use shall be submitted by WID to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 8. Water right Certificates 76715, 76799, and 79439 are modified. The Department will issue superseding certificates describing the rights when it determines it is necessary for record keeping.
