OAR Chapter 690, Division 077 implements the statutes and provides the Department's procedures and criteria for evaluating short-term instream lease applications.

Findings of Fact

- 1. NUID and the DRC filed an application to lease a portion of Certificates 72279, 72283, and 72284 to instream use. The Department assigned the application number L-744.
- 2. The description of the portion of the first right to be leased, Certificate 72279, has been modified from the lease application to correctly describe the place of use and is as follows (modifications shown in bold and italics):

Certificate: 72279

Season of Use: April 1 to November 1 (by Decree)

Priority Date: February 28, 1913

Quantity: Rate: 4.3 Cubic Foot per Second (CFS) (proportioned rate)

Duty: 1025.85 Acre-Feet (AF)

Source: Deschutes River, Wickiup Reservoir, constructed under Permit R-1677, and

Haystack Reservoir, constructed under Permit R-1754, tributaries of the

Columbia River

5. The Department provided notice of the lease application pursuant to OAR 690-077-0077(6) on May 16, 2006. Timely comments were received from the Bureau of Reclamation (BOR) on June 6, 2006, which raised concerns regarding the leasing of a portion of certificate 72279 to instream use. This certificate includes the diversion of water from two storage facilities, Haystack Reservoir and Wickiup Reservoir, owned by the BOR. There is no contract agreement between NUID and the BOR allowing the release of water from these reservoirs for instream purposes. In addition, the BOR has identified that pursuant to OAR 690-077-0077 (2)(b) that they would need to be a co-lessor on any lease that would include the use of stored water from either of these reservoirs for instream use. The BOR request that any water leased instream under certificate 72279 be limited to live flow only from the Deschutes River.

- 6. Pursuant to OAR 690-077-0077 (2)(b), the owner of any storage facility which is the source of water for a lease must be a co-lessor. The BOR is not a co-lessor to this lease.
- 7. Certificate 72279 allows the diversion of water from the Deschutes River, Haystack Reservoir and Wickiup Reservoir, as described in Finding of Fact #2. However, the lease application, in Section 2.2 of the lease application, describes that the source of water for the proposed lease is the Deschutes River. As the BOR is not a co-lessor on this lease, the lease of water under certificate 72279 shall be limited to live flow from the Deschutes River.
- 8. The lease application includes the information required under OAR 690-077-0077(3).
- 9. The instream use is clarified and modified from the lease application to prevent injury and enlargement, and to account for a small adjustment in the portion of certificate 72279 to be leased instream, and is as follows:

Deschutes River, tributary to the Columbia River

Instream Reach: From the POD (as described in Finding of Fact #2) to Lake Billy Chinook.

10. Other conditions to prevent injury and enlargement are:

Water leased instream under Certificate 72279 shall only be limited to live flow from the Deschutes River.

- 11. Based upon review of the application, comments received, information provided by the Department's Watermaster, and other available information, the Department finds that the lease will not result in injury or enlargement. This finding is made through an abbreviated review recognizing that the lease may be modified or revoked under OAR 690-077-0077 if the Department later finds that the lease is causing injury to any existing water right or enlargement of the original right.
- 12. If a right which has been leased is later proposed to be leased again or transferred to an instream use under ORS 537.348 and OAR 690-077-0070 or OAR 690-077-0075 a new injury review shall be required. Transfers will be subject to a full and complete review to

determine consistency with the requirements of OAR Chapter 690, Division 380 and Division 077. Approval of this lease does not establish a precedent for approval of future leases or transfers.

13. The lease will terminate on November 30, 2006, the last day of the irrigation season on the Crooked River.

CONCLUSIONS OF LAW

The Department concludes that the lease will not result in injury or enlargement, OAR 690-077-0077. The lease agreement conforms to the applicable provisions of OAR 690-077-0015.

ORDER

Therefore, it is ORDERED:

- 1. That the Short-Term Lease as described herein is APPROVED.
- 2. The former place of use shall no longer receive water as part of these rights during the term of the lease.
- 3. The lease shall terminate on November 30, 2006.
