ORDER APPROVING TEMPORARY CHANGES IN PLACE OF USE AND POINT OF DIVERSION

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 8046 submitted by

ROI JEAN LAURANCE 8559 TILLER TRAIL HIGHWAY CANYONVILLE, OREGON 97417.

The right to be modified, as evidenced by a portion of Certificate 66488, was perfected under Permit 42555 with a date of priority of SEPTEMBER 14, 1977. The right allows the use of the SOUTH UMPQUA RIVER, a tributary of the UMPQUA RIVER, for IRRIGATION of 10.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.13 cubic foot per second, if available at the authorized point of diversion: SE¼ SE¼, as projected within DLC 39, SECTION 7, T 30 S, R 4 W, WM; 850 FEET NORTH AND 20 FEET WEST FROM THE SE CORNER, SECTION 7, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2% acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SW% SW% 10.0 ACRES as projected within DLC 42 SECTION 8
TOWNSHIP 30 SOUTH, RANGE 4 WEST, W.M.

The right to use the water for the above purpose is restricted

- 1. The change is temporary. The change shall be effective upon issuance of this order.
- 2. The former place of use shall not be irrigated as part of this water right during the 1998 irrigation season.
- 3. The use shall revert to the authorized place of use at the end of the 1998 irrigation season.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
- 5. The use of the remaining water right described by Certificate 66488 shall continue to be in accordance with the terms and conditions of Certificate 66488.
