SATISFACTORY PROOF**

Authority

OAR 690-385-7600 describes the process for the Water Resources Department to issue a water right certificate upon determination that an applicant has made satisfactory proof of completion of the changes authorized by a final order approving a district permanent transfer.

Findings of Fact

1. On January 7, 2011, the Department issued a final order, recorded in Special Order Volume 83, Pages 351 – 355, approving district permanent transfer application T-11158. The order established October 1, 2012, as the date for completion of the authorized change in place of use.
2. On November 7, 2012, the Department received a Claim of Beneficial Use (CBU) and associated maps from the applicant.
3. The Department reviewed the CBU and maps submitted by the applicant for Transfer Application T-11158.
4. The CBU did not contain map(s) of the point(s) of diversion from the source. However, since the transfer involved the transfer of places of use only within an irrigation district, and did not involve changes in point of diversion, the existing map(s) on file with the Department are sufficient to identify the point(s) of diversion from the source.
5. The final proof map for a portion of this transfer reconfigures a portion of the place of use under District Notices #2010-013 and 2009-044. The reconfiguration is deemed satisfactory because the number of acres has not increased and the water right holder remains the same.

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

6. The CBU and associated maps noted changes in ownership for those parcels involved in District Notice #2009-038. The original water user was the Craig and Christy Christiansen Revocable Trust. The new water user is Rock Mesa, LLC.
7. A scrivener's error in the final order approving this transfer was noted. The incorrect location was listed in the order as follows:

8. The correct location for the parcel noted above is as follows:

9. Satisfactory proof of the changes was submitted with evidence showing that water was used in the location and for the purpose as authorized by the final order (see Finding of Fact #5 for reconfigured place of use notation) approving Transfer Application T-11158.


Conclusions of Law

Pursuant to OAR 690-385-7600, the Department may issue a certificate upon a determination that the application of water to beneficial use under the terms of the final order approving a permanent district transfer was completed to the extent authorized.

Now, therefore, it is ORDERED:

1. The Department has determined that the application of water to beneficial use under the terms of the final order approving permanent district Transfer Application T-11158 was completed to the extent authorized.
2. Pursuant to OAR 690-385-7600, the Department will issue a water right certificate on a determination that it is necessary to produce a certificate describing the right.
