Findings of Fact

- 1. On August 11, 2020, the Department issued an order approving Permit Amendment Application T-13426. The order was recorded at Special Order Volume 117, Pages 270 to 272. Superseding Permit G-18472 was subsequently issued by the Department.
- 2. Superseding Permit G-18472 contained a scrivener's error in identifying the well locations as follows:

- 2. All other provisions of Special Order Volume 117, Pages 270 to 272 remain in effect.
