Use, Marion County ) INSTREAM LEASE IL-1709

Oregon Revised Statute (ORS) 537.348 establishes the process in which a water right holder may submit a request to lease an existing water right for instream purposes. Oregon Administrative Rule (OAR) Chapter 690, Division 077 implements the statutes and provides the Department's procedures and criteria for evaluating instream lease applications.

**Findings of Fact**

1. On October 17, 2018, Santiam Water Control District, Department of Public Safety Standards and Training, Oregon Department of Administrative Services, and the Oregon Department of Corrections filed an application to lease a portion of Certificate 68665 for instream use. The Department assigned the application number IL-1709.
2. On October 30, 2018, the Department provided notice of the lease application pursuant to OAR 690-077-0077(6). No comments were filed in response to this notice.
3. On July 24, 2019, the Department received a request from the Agent of record for the Lessors to withdraw the lease application.

**Conclusions of Law**


The Department concludes that this lease has been withdrawn and does not result in the protection of any instream flow pursuant to OAR 690-077-0077.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

**Now, therefore it is ORDERED:**

The Short-Term Lease application described herein is withdrawn.
