ORDER APPROVING AN ADDITIONAL POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8541 submitted by

MIKE AND JEAN RYAN 10008 DONALD ROAD NE AURORA, OREGON 97002.

The right to be modified, as evidenced by Certificate 52664, was perfected under Permit G-6181 with a date of priority of JULY 11, 1974. The right allows the use of A WELL, in the WILLAMETTE RIVER BASIN, for IRRIGATION OF 44.4 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.56 cubic foot per second, if available at the original well; NE% NW%, AS PROJECTED WITHIN CHILDERS DLC 46, SECTION 13, T 4 S, R 2 W, W.M.; 3030 FEET SOUTH AND 1000 FEET EAST FROM THE NW CORNER OF CHILDERS DLC 46, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

NE¼ SW¼ 1.4 ACRES SE% SW% 25.8 ACRES NW1/4 SE1/4 0.4 ACRE SW1/4 SE1/4 7.5 ACRES

ALL AS PROJECTED WITHIN CHILDERS DLC 46 SECTION 12

NE¼ NW¼ 9.3 ACRES AS PROJECTED WITHIN CHILDERS DLC 46 SECTION 13

TOWNSHIP 4 SOUTH, RANGE 2 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes an additional point of appropriation located:

SE' NW', AS PROJECTED WITHIN CHILDERS DLC 46, SECTION 13, T 4 S, R 2 W, W.M.; 680 FEET NORTH AND 980 FEET EAST FROM THE SW CORNER OF CHILDERS DLC 46.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- The proposed change shall be completed on or before 1. October 1, 2002.
- The quantity of water diverted at the new point of 2. appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.

- 3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 52664 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
