Findings of Fact

- On August 10, 2010, the Department signed a final order approving Transfer Application T-10998, which was mailed on August 11, 2010. The order was recorded at Special Order Volume 81, Pages 646-660.
- 2. The order contains errors in Findings of Fact #4, and #14. The order is issued to correct the errors itemized below.
- 3. In Finding of Fact #4, the following authorized place of use contained a scrivener's error in the section number. The correct section number is listed below; it has been corrected to from Section 13 to Section 25.

4. In Finding of Fact #4, the following lands were erroneously included as being authorized places of use for supplemental irrigation under Certificate 79929:

These 0.2 acres are not authorized under Certificate 79929. Thus, the incorrect number of 58.75 acres as the total for authorized places of use under Certificate 79929 subject to T-12220 is corrected to a total of 58.55 acres.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Within 20 days after this final order is issued (i.e., mailing date), the district or any protestant may file with the commission exceptions to the final order. The commission shall issue an order granting or denying the exceptions within 30 days after receiving the exceptions. ORS 540.580(10).

5. In Finding of Fact #4, the following lands located in the SE1/4 SW1/4, Section 20, Township 5 North, Range 27 East, W.M. were incorrectly included as being a proposed place of use for supplemental irrigation under Certificate 79929:

Thus, the incorrect number of 22.6 acres for the total proposed place of use under Certificates 79928 and 79929 subject to T-10998 is corrected to a total of 22.7 acres.
