## **Authority**

ORS 537.610, 537.705 and 540.505 to 540.580 establish the process in which the holder of a certificate of registration may submit a request for recognition of modifications to the place of use, character of use or point of appropriation under a ground water certificate of registration.

OAR Chapter 690, Divisions 382 and 380 implement the statutes and provide the Department's procedures and criteria for evaluating ground water registration modification applications.

# **Findings of Fact**

# Background

- 1. On April 9, 2007, Anthony B. Turner and Joyce L. Turner filed a ground water registration modification application to modify the point of appropriation under Registration Application GR-1133 (Certificate of Registration GR-1093). The Department assigned the application number T-10366.
- 2. The applicant submitted a revised application map on September 4, 2007, that correctly identifies the scale of the map.
- 3. On September 5, 2007, Registration Application GR-1133 (Certificate of Registration GR-1093) was assigned from Andrew J. and Mabel Gilmore to Anthony B. Turner and Joyce L. Turner.

#### NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

5. The Department received information that better describes the location of the original point of appropriation in Finding #4 as follows:

6. Application T-10366 proposes to modify the point of appropriation under the ground water registration. The proposed new point of appropriation, located approximately 75 feet north from the original well, is located as follows:

- 7. Notice of the application for ground water registration modification was published on April 17, 2007, pursuant to OAR 690-382-0600. No comments were filed in response to the notice.
- 8. On October 5, 2007, the Department mailed a copy of the draft Preliminary Determination proposing to approve recognition of Ground Water Registration Modification Application T-10366 to the applicants. The draft Preliminary Determination set forth a deadline of November 5, 2007, for the applicants to respond. On October 10, 2007, the applicants requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.

9. On October 17, 2007, the Department issued a Preliminary Determination proposing to approve recognition of Ground Water Registration Modification Application T-10366 and mailed a copy to the applicants. Additionally, notice of the Preliminary Determination for the application was published on the Department's weekly notice on October 23, 2007, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

# Review Criteria for Ground Water Registration Modification Applications [OAR 690-382-0700(2)]

- 10. The proposed modification would not result in enlargement of the ground water registration.
- 11. The proposed modification would not result in a state Scenic Waterway not receiving previously available water during periods in which streamflows are less than the quantities determined by the Department to be necessary to meet the requirements of ORS 390.835.
- 12. The proposed modification would not result in injury to other water rights.

# **Conclusions of Law**

The modification in point of appropriation proposed in Application T-10366 is consistent with the requirements of ORS 537.610, 537.705, 540.505 to 540.580 and OAR 690-382-1000.

### Now, therefore, it is ORDERED:

- 1. The modification to Registration Application GR-1133 (Certificate of Registration GR-1093) proposed in Application T-10366 is recognized. Recognition of the modification shall not be construed as a final determination of the right to appropriate ground water under the certificate of registration or modification. Such a determination will occur in an adjudication proceeding under ORS 537.670 to 537.695.
- 2. The use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Registration Application GR-1133 (Certificate of Registration GR-1093) and any related decree.
- 3. Water shall be acquired from the same ground water aquifer (water source) as the original point of appropriation.
- 4. Water shall no longer be appropriated from the original point of appropriation as part of this ground water certificate of registration.
- 5. The quantity of water diverted at the new point of appropriation shall not exceed the quantity of water lawfully available at the original point of appropriation.

6. When required by the Department, the water user shall install and maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water appropriated. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
