#### ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7424 submitted by

GLENN CHOWNING P.O. BOX 862 HERMISTON, OREGON 97838.

The first right to be modified, as evidenced by a portion of Certificate 52396, was perfected under Permit 45563 with a date of priority of FEBRUARY 5, 1981. The right allows the use of the COLUMBIA RIVER, a tributary of the PACIFIC OCEAN, for IRRIGATION OF 12.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 45.4 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.50 cubic foot per second, if available at the authorized point of diversion: NE¼ NW¼ (LOT 7), SECTION 2, T 4 N, R 25 E, WM; 150 FEET SOUTH AND 2990 FEET WEST FROM THE NORTHEAST CORNER, SECTION 2, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acrefeet for each acre irrigated during the irrigation season of each year, provided further that although declared herein to be for supplemental irrigation in part the right allowed may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply provided that the total quantity diverted from all sources of supply does not exceed the limitation allowed herein.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

SUPPLEMENTAL IRRIGATION SW¼ SE¼ 16.6 ACRES SE¼ SE¼ 28.8 ACRES

# SECTION 10 TOWNSHIP 3 NORTH, RANGE 26 EAST, W.M.

The second right to be modified, as evidenced by a PORTION of Certificate 51992, was perfected under Permit G-1070 with a date of priority of AUGUST 27, 1958. The right allows the use of A WELL, in the COLUMBIA RIVER BASIN, for IRRIGATION OF 5.2 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.06 cubic foot per second, if available at the original well; SW¼ NE¼, SECTION 10, T 3 N, R 26 E, WM; 1350 FEET SOUTH AND 1430 FEET WEST FROM THE NORTHEAST CORNER, SECTION 10, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the place of use to:

TOWNSHIP 3 NORTH, RANGE 26 EAST, W.M.

The third right to be modified, as evidenced by a PORTION of Certificate 50167, was perfected under Permit G-1322 with a date of priority of MARCH 11, 1959. The right allows the use of A WELL, in the COLUMBIA RIVER BASIN, for IRRIGATION OF 40.2 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.39 cubic foot per second, if available at the original well; NE¼ SW¼, SECTION 10, T 3 N, R 26 E, WM; 1380 FEET NORTH AND 1320 FEET EAST FROM THE SOUTHWEST CORNER, SECTION 10 (shown on Certificate 31194 as 75 FEET NORTH AND 20 FEET EAST FROM THE CENTER OF SW¼), or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

SW¼ SE¼ 25.9 ACRES SE¼ SE¼ 14.3 ACRES

SECTION 10

TOWNSHIP 3 NORTH, RANGE 26 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the place of use to:

SW¼ SE¼ 11.4 ACRES SE¼ SE¼ 28.8 ACRES SECTION 10 TOWNSHIP 3 NORTH, RANGE 26 EAST, W.M.

THESE CHANGES TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed changes shall be completed on or before October 1, 1999.
- 2. When required by the Department, the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 3. The former place of use shall no longer be irrigated as part of this water right.

Certificates 52396, 51992 and 50167 are canceled. New certificates will be issued to confirm those portions of the rights NOT involved in this transfer. When satisfactory proof of the completed changes are received, new certificates confirming these water rights will be issued.
