ORDER AMENDING  
ORDER


The order of the Water Resources Director, entered June 8, 1976, and recorded at page 251, Volume 27, Special Order Record, in the above entitled matter, contained an error in the final paragraph as a result of a clerical error in preparation of said order.

The final paragraph of said order provides: "NOW, THEREFORE, it hereby is ORDERED that the right for the use of not to exceed 0.54 cubic foot per second of the waters of Griswell Creek for the irrigation of 0.8 acre in NW $\frac{1}{4}$  NE $\frac{1}{4}$ , 0.3 acre in SW $\frac{1}{4}$  NE $\frac{1}{4}$ , 1.1 acres in NE $\frac{1}{4}$  NW $\frac{1}{4}$ , 1.4 acres in NE $\frac{1}{4}$  SE $\frac{1}{4}$ , 4.6 acres in NW $\frac{1}{4}$  SE $\frac{1}{4}$ , 2.9 acres in SW $\frac{1}{4}$  SE $\frac{1}{4}$ , 11.4 acres in SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 5, and 11.5 acres in NE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 8, Township 1 South, Range 10 East, W.M., with a date of priority of June 16, 1924, is canceled." (Emphasis supplied.)

The order should have provided: "... 14.1 acres in NW $\frac{1}{4}$  SE $\frac{1}{4}$  ...".

NOW, THEREFORE, it hereby is ORDERED that the final paragraph of the order of the Water Resources Director, entered on June 8, 1976, in the above entitled matter, and recorded at page 251, Volume 27, Special Order Record, be, and the same hereby is, amended to provide: "NOW, THEREFORE, it hereby is ORDERED that the right for the use of not to exceed 0.54 cubic foot per second of the waters of Griswell Creek for the irrigation of 0.8 acre in NW $\frac{1}{4}$  NE $\frac{1}{4}$ , 0.3 acre in SW $\frac{1}{4}$  NE $\frac{1}{4}$ , 1.1 acres in NE $\frac{1}{4}$  NW $\frac{1}{4}$ , 1.4 acres in NE $\frac{1}{4}$  SE $\frac{1}{4}$ , 14.1 acres in NW $\frac{1}{4}$  SE $\frac{1}{4}$ , 2.9 acres in SW $\frac{1}{4}$  SE $\frac{1}{4}$ , 11.4 acres in SE $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 5; and 11.5 acres in NE $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 8, Township 1 South, Range 10 East, W.M., with a date of priority of June 16, 1924, is cancelled."
