**Authority**

ORS 540.570 establishes the process in which a district may submit a request to temporarily transfer a water right within district boundaries. OAR Chapter 690, Division 385 implements the statutes and provides the Department’s procedures and criteria for evaluating district transfer applications.

**Findings of Fact**

**Background**

1. On May 11, 2009, WEST EXTENSION IRRIGATION DISTRICT filed an application to temporarily change the place of use under Certificates 79924, 79926, 79928, 79929 and 79930 for a period of one year. The Department assigned the application number T-10875.
2. On July 10, 2009, the Department received amendments correcting the transfer maps and application. Pursuant to OAR 690-385-3110, West Extension Irrigation District specified water use on the “FROM” lands and proposed “TO” lands under existing Certificates 44107, 62156, 79940, 82169, 53069 and Permit G-12054 will not be used or transferred during the course of the 2009 Irrigation Season, and are fully described in Findings of Facts #6, #8, #11 and #14.
3. The portion of the FIRST primary right and its layered supplemental water right to be transferred are as follows:
  - Certificate:** 79924 in the name of WEST EXTENSION IRRIGATION DISTRICT (confirmed by the Umatilla River Decree)
  - Use:** IRRIGATION of 31.1 ACRES
  - Priority Date:** APRIL 14, 1893
  - Rate:** 0.39 CUBIC FOOT PER SECOND (cfs)

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60days following the date the petition was filed, the petition shall be deemed denied.

14. West Extension Irrigation District has stated in the transfer application that a portion of water right Certificate 44107 for primary irrigation, existing on the "TO" lands, will not be used or transferred during the term of this temporary transfer. The affected right is as follows:

15. Notice of the application for transfer was published on May 26, 2009, pursuant to ORS 540.570 and OAR 690-385-3400. No comments were filed in response to the notice.
16. Water has been used within the last five years according to the terms and conditions of the rights and there is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
17. Diversion structures, pumps, canals, pipeline, and sprinkler systems sufficient to use the full amount of water allowed under the existing rights are present.
18. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
19. The proposed changes would not result in enlargement of the rights.
20. The proposed changes would not result in injury to other water rights. This finding is made through an abbreviated review recognizing that the transfer may be revoked under ORS 540.570(6) if the Department later finds that the transfer is causing injury to any existing water right.
21. The district temporary transfer application satisfies the criteria of OAR 690-385-3000, contains the information required under OAR 690-385-2000, and includes maps meeting the requirements of OAR 690-385-2200.

### Conclusions of Law

The temporary changes in place of use proposed in Transfer Application T-10875 are consistent with the requirements of ORS 540.570 and OAR 690-385-3000.


### Now, therefore, it is ORDERED:

1. The proposed, temporary changes to the water rights evidenced by Certificates 79924, 79926, 79928, 79929 and 79930 are approved.
2. The temporary transfer is effective for the 2009 irrigation season.



3. The former places of use **shall not** be irrigated as part of these water rights during the 2009 irrigation season.
4. At the end of the 2009 irrigation season all use of water under this temporary transfer shall automatically revert to the terms and conditions of the original water right permit, certificates or adjudication as evidenced by a court decree.
5. The use of water under this temporary transfer may be conditioned or revoked at any time to the extent necessary to avoid injury if the Department finds the transfer causes injury to any existing water right.
6. A subsequent application for permanent transfer of Certificates 79924, 79926, 79928, 79929 and 79930 shall be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 380. Approval of this temporary transfer does not establish a precedent for approval of a subsequent application filed for a permanent transfer.
7. The use of water at the temporary place of use authorized by this transfer shall be in accordance with the terms and conditions of Certificates 79924, 79926, 79928, 79929 and 79930.
8. The time during which water is used under this approved temporary transfer does not apply toward a finding of forfeiture under ORS 540.610.
9. The portions of Certificates 44107, 62156, 79940, 82169 53069 and water use Permit G-12054 described in Findings of Fact #6, #8, #11 and #14 will not be used or transferred during the 2009 irrigation season.
10. The use of the remaining water rights described by Certificates 79924, 79926, 79928, 79929 and 79930 shall continue to be in accordance with the terms and conditions of Certificates 79924, 79926, 79928, 79929 and 79930.
11. The water user shall maintain and operate the existing measurement devices and shall make such improvements as may be required by the Department.
