## ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 8577 submitted by

VIDMA WILLSON P.O. BOX 667 MYRTLE POINT, OREGON 97458.

The right to be modified, as evidenced by Certificate 39384, was perfected under Permit 29490 with a date of priority of APRIL 20, 1964. The right allows the use of the NORTH FORK COQUILLE RIVER, a tributary of the COQUILLE RIVER, for IRRIGATION OF 19.8 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.25 cubic foot per second, if available at the authorized point of diversion: LOT 3 (SW% SE%), SECTION 4, T 29 S, R 12 W, W.M.; 550 FEET SOUTH AND 460 FEET EAST FROM THE NW CORNER, LOT 3 (SW% SE%), SECTION 4, or its equivalent in case of rotation, measured at the point of diversion from the source.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

NE¼ SW¼ 1.9 ACRES Lot 3 (SE¼ SW¾) 9.5 ACRES

Lot 3 (SW¼ SE¼) 8.4 ACRES

SECTION 4

TOWNSHIP 29 SOUTH, RANGE 12 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes to TEMPORARILY change the place of use to:

NE% NW% 19.8 ACRES

SECTION 9

TOWNSHIP 29 SOUTH, RANGE 12 WEST, W.M.

THIS TEMPORARY CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The change is temporary. The change shall be effective upon issuance of this order.
- The former place of use shall not be irrigated as part of this water right during the 2000, 2001, 2002, 2003 and 2004 irrigation seasons.

- 3. The use shall revert to the authorized place of use at the end of the 2004 irrigation season.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
