OAR 690-385-7200 establishes an application process and criteria for the review of extensions of time for the completion of changes authorized under water right transfers.

Findings of Fact

Background

1. The Water Resources Department issued an order approving Transfer Application T-10995 in the name of Central Oregon Irrigation District on February 26, 2010. The order was recorded in Special Order Volume 80, at Pages 353 - 357. The order set a transfer completion date of October 1, 2011.
2. On August 20, 2012, the Department received from COID an application for extension of time for Transfer Application T-10995.
3. The applicant, working with the landowners and water users, has completed the application of irrigation water to beneficial use on all parcels except a 1.95 acre portion of Tax Lot 311 in T17S R12E, Section 13. This parcel is associated with District Internal Notice Number T-2009-030.
4. The district and district water user has been unable to fully complete the changes by the deadline because the property was in foreclosure since the end of 2010. The parcel has recently been purchased.
5. To fully complete the application of irrigation water to beneficial use, it will be necessary for the applicant to assure the water user irrigates the 1.95 acres at the following location:

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

6. Central Oregon Irrigation District has requested that the time for completion of beneficial use be extended to October 1, 2013.


Conclusions of Law

Now, therefore, it is ORDERED:

The time for completion of beneficial use authorized by T-10995 is extended to October 1, 2013.
