6. This order is issued to correct the scrivener's errors described in Finding of Fact 5, above, and supersedes the final order approving Transfer Application T-11516, recorded in Special Order Volume 89, Pages 160-172. All corrections and deletions are consistent with the maps submitted with the application and the water rights of record. The corrections to the authorized and proposed places of use are show in **bold**, deletions are shown in ~~strikeout~~.

*Limit/Duty:* The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 88.87 cubic feet per second (cfs) into Medford Canal at Bradshaw Drop. The total diversions though the Main Canal from North Fork and South Fork of the Little Butte Creek shall not exceed 140 cfs at any one time, being 50 cfs for Rogue River Valley Irrigation District and 90 cfs for Medford Irrigation District. Total diversions from South Fork Little Butte Creek shall not exceed 100 cfs at any one time. The amount of water used for irrigation is limited to 1/100<sup>th</sup> of one cubic foot per second or its equivalent for each acre irrigated during the season.

The amount of water used for irrigation together with the amount secured under any other right existing of the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year provided that the combined uses of water under permits S-25915 and S-25916, and all certificates issue in respect thereto, shall not exceed the maximum rate listed for each source above, at any one point in time.

The changes in place of use as proposed in Transfer Application T-11516 satisfies the requirements of ORS 540.574(3) and 540.580.


#### Now, therefore, it is ORDERED:

1. The order entered at Special Order Volume 89, Pages 160-172 is withdrawn and of no further force and effect and is superseded by this order.
2. The changes in place of use as proposed in Transfer Application T-11516 to the water rights evidenced by Certificates 83381, 83383, 80578, 83728 and water use Permit S-4951 are approved.
3. The right to the use of water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in by Certificates 83381, 83383, 80578, 83728 and water use Permit S-4951 any related decree or order.
4. The former places of use shall no longer be irrigated as part of these water rights or water use permit.
5. The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.
6. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before October 1, 2014. A Claim of Beneficial Use shall be submitted by MID to

the Department within one year after the deadline for completion of the changes and full beneficial use of the water.

7. Water right by Certificates 83381, 83383, 80578, 83728 and water use Permit S-4951 are modified. The Department will issue a superseding certificate describing the rights when it determines that is necessary for record keeping.
