confirms the right to use the waters of the CRANE PRAIRIE RESERVOIR, a tributary of the DESCHUTES RIVER, for SUPPLEMENTAL IRRIGATION of 6.31 ACRES.

This right was perfected under Permit S-23256. The date of priority is February 28, 1913. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed a portion of 50,000 acre-feet of stored water only for the entire right, if available at the authorized point of diversion from the source, limited to the duty of water as set out in the modified supplemental decree of the circuit court dated March 24, 1993, in the matter of the determination of the relative rights to the use of the water of the Deschutes River and its tributaries. The amount of water allowed under this right together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein, and is further limited to the terms of the Central Oregon Irrigation District, Crook County Improvement District #1, and the Arnold Irrigation District, and subject to such reasonable rotation system as may be ordered by the proper state officer.

The season of use is April 1 through November 1.

The authorized point of diversion is located as follows:

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482. Pursuant to ORS 183.482, ORS 536.075 and OAR 137-003-0675, you may petition for judicial review and petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

The quantity of water diverted at the additional/new point of diversion, together with that diverted at the original point of diversion, shall not exceed the quantity of water available from the original point of diversion described as follows:

The water user shall maintain a fish screen or fish by-pass device, as appropriate, at the point of diversion consistent with The Oregon Department of Fish and Wildlife's operational and maintenance standards.

The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department.

The water user shall maintain the existing headgate and shall make such improvements as may be required by the Department.


The right to the use of the water for the above purpose is restricted to beneficial use on place of use described, and is subject to all other conditions and limitations contained in Certificate 76714.

This order is issued to confirm a change in POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered FEBRUARY 26, 2008, at Special Order Volume 74, Page 270, approving Transfer Application 10466, affecting a portion of Certificate 76714, State Record of Water Right Certificates.

The Department will issue a superseding certificate describing the right when it determines that it is necessary for record keeping.
