ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8130 submitted by

WILDE RANCH 44142 BANTA ROAD BAKER CITY, OR 97814

The right to be modified, as evidenced by a portion of Certificate 57170, was perfected under Permit 36473 with a date of priority of AUGUST 24, 1971. The right allows the use of POWDER RIVER, a tributary of SNAKE RIVER, for IRRIGATION OF 24.1 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.42 cubic foot per second, if available at the authorized point of diversion: SW¼ SE¼, SECTION 17, T 8 S, R 42 E, WM; 650 FEET NORTH AND 2540 FEET WEST FROM SE CORNER, SECTION 17, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SW¼ NE¼ 24.1 ACRES SECTION 30 TOWNSHIP 8 SOUTH, RANGE 42 EAST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes to change the place of use to:

SW¼ SE¼ 3.5 ACRES SECTION 29 4.5 ACRES NW¼ NE¼ SW¼ NE¼ 16.1 ACRES SECTION 32

TOWNSHIP 8 SOUTH, RANGE 42 EAST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- The proposed change shall be completed on or before October 1, 1. 2000.
- The former place of use shall no longer be irrigated as a part 2. of this water right.

Certificate 57170 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
