IN THE MATTER OF THE APPLICATION OF THE CITY OF SALEM, OREGON, AND THE OREGON PULP AND PAPER COMPANY FOR THE APPROVAL OF A CHANGE IN USE, PLACE OF USE AND POINT OF DIVERSION OF WATER FROM THE NORTH SANTIAM RIVER.

ORDER

AMENDING ORDER OF SEPTEMBER 10, 1951

On September 10, 1951 the State Engineer entered an order approving an application of the City of Salem, Oregon and the Oregon Pulp and Paper Company for the approval of a change in use, place of use and point of diversion of water from North Santiam River.

From an examination of the last paragraph of Page 3 of the said order, it appears that the second proposed point of diversion to be utilized by the City of Salem is erroneously described as being 660 feet east from the northwest corner of the  $NW_4^1$   $NE_4^1$ , Section 13, Township 9 South, Range 1 West, W. M., whereas said second proposed point of diversion should have been described as being located 830 feet south and 660 feet east from the northwest corner of the  $NW_4^1$   $NE_4^1$ , said Section 13, Township 9 South, Range 1 West, W. M., said last paragraph reading as follows:

"IT IS FURTHER ORDERED that the proposed change in point of diversion of water from North Santiam River to-wit:

"From a point located approximately 370 feet south and 565 feet east from the northwest corner of  $SW_{\frac{1}{4}}$   $SE_{\frac{1}{4}}$  and being within the southeast quarter, Section 11, Township 9 South, Range 1 West, W. M.,

"To two new points of diversion, namely, the first to be located approximately 620 feet south and 120 feet west from the northeast corner of the SW4 NE4, Section 13, Township 9 South, Range 1 West, W. M., and the second to be located 660 feet east from the northwest corner of the NW4 NE4, Section 13, Township 9 South, Range 1 West, W. M.,

for municipal purposes within the corporate limits of the City of Salem, Oregon and surrounding territory with a date of priority of 1856, be and the same hereby is approved."

It appears that the error should be corrected and a supplemental order be entered deleting the last paragraph of page 3 of said original order and inserting in lieu thereof the following paragraph:

IT IS FURTHER ORDERED that the proposed change in point of diversion of water from North Santiam River to-wit:

From a point located approximately 370 feet south and 565 feet east from the northwest corner of SW 3E 4, and being wint the southeast quarter, Section 11, Township 9 South, Range 1 West, W. M.,

To two new points of diversion, namely, the first to be located approximately 620 feet south and 120 feet west from the northeast corner of the  $SW_{4}^{1}$   $NE_{4}^{1}$ , Section 13, Township 9 South, Range 1 West, W. M., and the second to be located 830 feet south and 660 feet east from the northwest corner of the  $NW_{4}^{1}$   $NE_{4}^{1}$ , Section 13, Township 9 South, Range 1 West, W. M.,

for municipal purposes within the corporate limits of the City of Salem, Oregon and surrounding territory with a date of priority of 1856, be and the same is hereby approved.

NOW, THEREFORE, it is hereby ORDERED that the following paragraph be substituted for the last paragraph of page 3 of the State Engineer's order entered September 10, 1951, approving the application of City of Salem, Oregon and Oregon Pulp and Paper Company for a change in use, place of use and point of diversion of water from North Santiam River:

IT IS FURTHER ORDERED that the proposed change in point of diversion of water from North Santiam River to-wit:

From a point located approximately 370 feet south and 565 feet east from the northwest corner of  $SW_2^+$   $SE_2^+$  and being within the southeast quarter, Section 11, Township 9 South, Range 1 West, W. N.,

To two new points of diversion, namely, the first to be located approximately 620 feet south and 120 feet west from the northeast corner of the SW1 NE1, Section 13, Township 9 South, Range 1 West, W. M., and the second to be located 830 feet south and 660 feet east from the northwest corner of the NW1 NE1, Section 13, Township 9 South, Range 1 West, W. M.,

for municipal purposes within the corporate limits of the City of Salem, Oregon and surrounding territory with a date of priority of 1856, be and the same is hereby approved.
