Findings of Fact

- 1. On March 25, 2004, Clackamas County filed an application to add four additional points of appropriation under Permit G-13947. The Department assigned the application number T-9682.
- 2. The permit to be amended is as follows:

G-13947, in the name of COUNTY OF CLACKAMAS; DAN ZINZER

Use:

IRRIGATION and MAINTENANCE of FOUR RESERVOIRS constructed

under Permit R-11390

Priority Date: JULY 21, 2000

Quantity:

1.859 CUBIC FEET PER SECOND (CFS), being 1.52 cfs for irrigation and

0.339 cfs for reservoir maintenance

Rate/Duty:

The amount of water used for irrigation, together with the amount secured

under any other right existing for the same lands, is limited to ONE-

EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

- 4. Notice of the application for permit amendment was published on April 20, 2004, pursuant to ORS 540.520(5). No comments were filed in response to the notice.
- 5. A Department staff hydrogeologist determined on July 12, 2004, that the proposed additional points of appropriation (wells) do not appropriate water from the same ground water source (ground water aquifer) as the authorized wells under Permit G-13947.
- 6. Based upon the determination described in Finding #5, the Department cannot make a finding of non-injury to other water rights.
- 7. Based upon the determination described in Finding #5, the Department cannot make a finding of non-enlargement.
- 8. The proposed change would not alter the terms of the permit.
- 9. On May 22, 2006, the Department issued a draft final order proposing rejection of Permit Amendment Application T-9682 and sent a copy to the applicant. The draft final order set forth a deadline of June 21, 2006, in which the applicant was given an opportunity to respond and amend the application or provide additional evidence that could impact the Department's final decision. The Department did not receive any such response from the applicant regarding the draft final order for Permit Amendment T-9682.

Conclusions of Law

The additional points of appropriation proposed by Permit Amendment Application T-9682 are **not** consistent with the requirements of ORS 537.211, as described in Findings #5, #6 and #7 above.

Now, therefore, it is ORDERED:

Permit Amendment T-9682, in the name of Clackamas County; Dan Zinzer, is rejected.
