**Authority**

Oregon Revised Statutes (ORS) 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. Oregon Administrative Rules (OAR) Chapter 690, Division 380 implement the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

ORS 540.621 establishes the process for the owner of land to which a water right is appurtenant to certify under oath that the water right, or a portion thereof, has been abandoned and to voluntarily request that it be cancelled.

**Findings of Fact**

1. On April 20, 2020, STEPHEN JENSEN filed an application to change the place of use and to change the character of use under Certificate 16028, and to cancel a portion of Certificate 23127. The Department assigned the application number T-13422.
2. Notice of the application for transfer was published on May 12, 2020, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

3. On September 17, 2020, the Department contacted the applicant by written correspondence to notify the applicant and the applicant's agent of deficiencies in the application. The application did not include a Supplemental Form D, as the place of use is located within Talent Irrigation District, and a copy of the deed and a map was not included with the Affidavit for Partial Cancellation of a Water Right Certificate. The Department requested that the deficiencies be resolved by November 2, 2020.
4. On September 21, 2020, the applicant's agent submitted a Supplemental Form D, and a copy of the deed and map to accompany the Affidavit for Partial Cancellation, resolving the deficiencies.
5. On October 8, 2020, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-13422 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of November 9, 2020, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
6. On January 19, 2021, the Department issued a Preliminary Determination proposing to approve Transfer T-13422 and mailed a copy to the applicant. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on January 26, 2021, and in the Medford Mail Tribune newspaper on January 28 and February 4, 2021 pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

7. The portion of the right to be transferred is as follows:

**Certificate:** 16028 in the name of J. A. PARKER (confirmed by Rogue River Final Decree)  
**Use:** IRRIGATION of 0.14 ACRE and STOCK  
**Priority Date:** 1858  
**Rate:** 0.003 CUBIC FOOT PER SECOND  
**Source:** ASHLAND CREEK, a tributary of BEAR CREEK

**Authorized Place of Use:**

8. Transfer Application T-13422 proposes to change the place of use of the right to:

9. Transfer Application T-13422 also proposes to change the character of use from stock to irrigation.

10. Certificate 16028 does not specify a period of allowed use; however, stock use is generally considered a year-round use. Irrigation would be limited to the irrigation season. Certificate 16028 does not specify an irrigation season; however, consistent with the Rogue River Decree, the irrigation season is April 1 through October 31. Information contained in the decree allows water to be diverted for stock year round; during the irrigation season water diverted for irrigation purposes includes water diverted for stock.
11. Certificate 16028 does not specify a total quantity of water to be diverted annually for stock use. The Department recognizes 0.005 cubic foot per second (cfs) as an allowable rate for stock. If diverted continuously at the authorized rate of 0.005 cfs for 365 days per year (0.005 cfs x 60 sec/min x 60 min/hr x 24 hr/day x 365 days/year ÷ 43,560 square feet per acre = 3.62 acre-feet per year), is the maximum that could have been diverted for stock.

***Transfer Review Criteria [OAR 690-380-4010(2)]***

12. Water has been used within the last five years according to the terms and conditions of the right. There is no information in the record that would demonstrate that the right is subject to forfeiture under ORS 540.610.
13. A diversion structure and ditch sufficient to use the full amount of water allowed under the existing right were present within the five-year period prior to submittal of Transfer Application T-13422.
14. The proposed changes, as conditioned, would not result in enlargement of the right.
15. The proposed changes, as conditioned, would not result in injury to other water rights.
16. All other application requirements are met.

***Partial Cancellation of a Water Right***

17. On April 20, 2020, an affidavit certifying that a portion of a water right has been abandoned and requesting cancellation of the right was received from Stephen Jensen. The right to be cancelled is as follows:

**Certificate:** 23127 in the name of B. H. CHRISTLIEB (perfected under Permit S-23819)  
**Use:** SUPPLEMENTAL IRRIGATION of 0.22 ACRES  
**Priority Date:** APRIL 15, 1955  
**Rate:** 0.006 CUBIC FOOT PER SECOND  
**Limit/Duty:** The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall also be limited to the water available at the proposed point of diversion, and shall not carry with it the right to compel the continuance of the waste water.

**Conclusions of Law**

The change in place of use and change in character of use proposed in Transfer Application T-13422 are consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000 and the abandoned right should be cancelled.


**Now, therefore, it is ORDERED:**

1. The change in place of use and change in character of use proposed in Transfer Application T-13422 are approved. The portion of the right that has been abandoned is cancelled.
2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificate 16028 and any related decree.
3. Water right Certificate 16028 is cancelled. A new certificate will be issued describing that portion of the rights not affected by this transfer and cancellation.
4. Water right Certificate 23127 is cancelled. A new certificate will be issued describing that portion of the right not affected by this transfer and cancellation.
5. The rate of diversion for the change in character of use from stock to the proposed irrigation use shall be limited to 0.005 cubic foot per second and shall be further limited, as identified in Finding of Fact 9, to a total volume diverted of 3.62 acre-feet during the period of authorized use, being November 1 through March 31 of each year.
6. The former place of use of the transferred right shall no longer receive water under the right.
7. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2022**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.

8. After satisfactory proof of beneficial use is received, a new certificate confirming the right transferred will be issued.
