O R D E R

On March 14, 1973, Richard D. and Ceraldine F. Downer submitted an affidavit that they are the owners of lands claimed to have been irrigated as described in a certificate of registration; that they have abandoned said claim of water right and requests the same be canceled.

The claimed right in question is for the use of not to exceed 160 gallons per minute from a pump well located 1452 feet North and 675 feet East of the Southwest corner of Section 30, being within the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 30, Township 10 South, Range 2 West, W.M., for irrigation of 10.9 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 25, Township 10 South, Range 3 West, W.M., and 2.0 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$, 19.4 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$ (erroneously listed as NW $\frac{1}{4}$ NW $\frac{1}{4}$), 0.5 acre in SW $\frac{1}{4}$ SW $\frac{1}{4}$ (erroneously listed as SW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 30, Township 10 South, Range 2 West, W.M., and is described in the certificate of registration recorded at page 2181, Volume 10, Ground Water Registration Records.

NOW, THEREFORE, it is hereby ORDERED that the claim of a water right for the use of not to exceed 160 gallons per minute from a pump well located 1452 feet North and 675 feet East of the Southwest corner of Section 30, being within the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 30, Township 10 South, Range 2 West, W.M., for irrigation of 10.9 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 25, Township 10 South, Range 3 West, W.M., and 2.0 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$, 19.4 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$ (erroneously listed as NW $\frac{1}{4}$ NW $\frac{1}{4}$), 0.5 acre in SW $\frac{1}{4}$ SW $\frac{1}{4}$ (erroneously listed as SW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 30, Township 10 South, Range 2 West, W.M., is canceled.
