O R D E R

On January 16, 1941, Ora E. Hemenway filed a petition in the office of the State Engineer for the issuance of a certificate of water right to correct that certain certificate of water right issued on May 12, 1930, to Ora E. Hemenway and recorded in State Record of Water Right Certificates in Volume 8, Page 8620.

On June 8, 1936, Ora E. Hemenway filed an application for a permit to appropriate 0.35 cubic foot per second of the waters of Barrett or Bramble Branch and City Creek for the irrigation of 30 acres in Section 30, Township 20 South, Range 3 West, W. M., described as follows:

11 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$
11 acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$
4 acres in NE $\frac{1}{4}$ SW $\frac{1}{4}$
4 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$

In making final proof of application of water to beneficial use, the lands irrigated were described as above and subsequently certificate of water right was issued to conform with such proof.

Based upon a survey made on November 2, 1940, by Howard Taylor, Surveyor, it was found that the lands actually irrigated are within the following subdivisions:

3 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$
14 acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$
7.5 acres in NE $\frac{1}{4}$ SW $\frac{1}{4}$
5.5 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 30,
Twp. 20 S., Rge. 3 W., W. M.

From the petition submitted by Mr. Hemenway, it appears that the 30 acres last above described were actually reclaimed and irrigated at the time of making proof of application of water to beneficial use and that water has been used continuously on said land each and every year thereafter.

It further appears that certificate heretofore issued to Ora E. Hemenway and recorded in State Record of Water Right Certificates in Volume 8, Page 8620, should be cancelled and a new certificate issued correctly describing the lands irrigated.

NOW, THEREFORE, it hereby is ORDERED that certificate of water right issued to Ora E. Hemenway and recorded in State Record of Water Right Certificates in Volume 8, Page 8620, be and the same hereby is cancelled and that a new certificate of water right be issued in lieu thereof to describe correctly the lands irrigated as follows:

3 acres in SW $\frac{1}{4}$ NW $\frac{1}{4}$
14 acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$
7.5 acres in NE $\frac{1}{4}$ SW $\frac{1}{4}$
5.5 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 30,
Twp. 20 S., Rge. 3 W., W. M.
