# BEFORE THE WATER RESOURCES DEPARTMENT OF THE STATE OF OREGON

ORS 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of appropriation, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

## **Findings of Fact**

- 1. Tom DeArmond filed an application to add a point of appropriation, under Certificates 39151, 56753, & 59003. The Department assigned the application number T-9414.
- 2. The first right to be transferred is as follows:

5. Application T-9414 proposes to add an authorized point of appropriation approximately 0.25 mile from the existing point of appropriation at Well 1 (identified as Well 6 on transfer application) and approximately 175 feet from the existing point of appropriation at Well 2 (identified as Well 7 on transfer application) in the Pudding River and Mill Creek basins to:

- 6. The maximum distance of the proposed new well is slightly more than ½ mile from Well 1 (identified as Well 6 on transfer application).
- 7. Notice of the application for transfer was published pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.
- 8. Water has been used within the last five years according to the terms and conditions of the rights, and no evidence is available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 9. Pumps, pipeline, and a sprinkler system sufficient to use the full amount of water allowed under the existing rights are present.
- 10. The proposed change would not result in enlargement of the rights.
- 11. The proposed change would not result in injury to other water rights.

#### Conclusions of Law

The change, to add a point of appropriation, proposed in application T-9414 is consistent with the requirements of ORS 537.705 and 540.505 to 540.580, and OAR 690-380-5000.

# Now, therefore, it is ORDERED:

- 1. The change, to add a point of appropriation, proposed in application T-9414 is approved.
- 2. Water right certificates 39151, 56753, and 59003 are cancelled.
- 3. The right to use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 39151, 56753, & 59003.
- 4. Water shall be acquired from the same aquifer (water source) as the original points of appropriation.
- 5. The proposed change shall be completed on or before October 1, 2006.
- 6. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department by October 1, 2007.
- 7. The quantity of water diverted at the new point of appropriation, together with that diverted at the original points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 8. When required by the Department, the water user shall install and maintain an in-line flow meter or other suitable device for measuring and recording the quantity of water appropriated. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 9. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
