ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 9157 submitted by

JANIS A. CONKLIN 4200 BLUE HERON CIRCLE, APT. A ANACORTES, WASHINGTON 98221.

The PORTION of the right to be modified, was perfected under Permit G-13078 with a date of priority of JULY 20, 1995. Proof to the satisfaction of the Director that use of water has been accomplished under the terms and conditions of Permit G-13078 has been received. The right allows the use of A WELL, in the GRANDE RONDE RIVER BASIN for IRRIGATION OF 7.2 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.09 cubic foot per second, if available at the original well located at:
NE% SE%, SECTION 10, T 3 S, R 39 E, W.M.; 1375 FEET NORTH AND 1289 FEET WEST FROM THE SE CORNER, SECTION 10, or its equivalent in case of rotation, measured at the well.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005, you may either petition for judicial review or petition the Director for reconsideration of this order.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.

SECTION 11

TOWNSHIP 3 SOUTH, RANGE 39 EAST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. This change is temporary. This change shall be effective upon issuance of this order.
- 2. The former place of use shall **not** be irrigated as part of this water right during the 2002, 2003, 2004, 2005 and 2006 irrigation seasons.

- 3. The use shall revert to the authorized place of use at the end of the 2006 irrigation season.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
- 5. The use of the remaining water right described by Permit G-13078 shall continue to be in accordance with the terms and conditions of Permit G-13078.
