ORDER APPROVING AN ADDITIONAL POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8792 submitted by

WEYERHAEUSER COMPANY, BY MELODY SYDOW

SPRINGFIELD, OREGON 97477.

The right to be modified, as evidenced by Certificate 20901, was perfected under Permit 17511 with a date of priority of MAY 21, 1947. The right allows the use of the MCKENZIE RIVER AND RESERVOIR CONSTRUCTED UNDER APPLICATION R-22550, PERMIT R-861, a tributary of the WILLAMETTE RIVER, for MANUFACTURING AND MAINTENANCE OF LOG POND. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 50.0 cubic feet per second, if available at the authorized point of diversion: LOT 2 (NE¼ NW¼), SECTION 32, T 17 S, R 2 W, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes an additional point of diversion located:

Lot 10 (NW $\frac{1}{4}$  SE $\frac{1}{4}$ ), SECTION 29, T 17 S, R 2 W, W.M.;  
1890 FEET NORTH AND 2910 FEET EAST FROM THE SW CORNER OF  
SECTION 29.


THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 2002.
2. The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.
3. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same surface water source as the original point of diversion.

Certificate 20901 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
