## ORDER APPROVING A CHANGE IN POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7317 submitted by

RALPH D. WORTHYLAKE 1577 HIGHWAY 234 EAGLE POINT, OREGON 97524.

The right to be modified, as evidenced by a portion of Certificate 72144, was perfected under Permit 298 with a date of priority of JULY 26, 1909. The right allows the use of the ROGUE RIVER, a tributary of the PACIFIC OCEAN, for IRRIGATION OF 2.5 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.013 cubic foot per second, if available at the authorized point of diversion: LOT 4 (NW¼ SE¼), SECTION 17, T 35 S, R 1 W, W.M.; 960 FEET SOUTH AND 3370 FEET EAST FROM THE W¼ CORNER, SECTION 17, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

LOT 4 (NW% SE%) 1.5 ACRES
LOT 3 (SW% SE%) 1.0 ACRES
SECTION 17
TOWNSHIP 35 SOUTH, RANGE 1 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes to change the point of diversion to:

SW½ SE½, SECTION 17, T 35 S, R 1 W, W.M.; 1240 FEET NORTH AND 3080 FEET EAST OF THE SW CORNER, SECTION 17.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1997.
- 2. The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.
- 3. The water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same surface water source as the original point of diversion.

Certificate 72144 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
