Authority

OAR Chapter 690, Division 086, establishes the process and criteria for approving water management and conservation plans required under the conditions of permits, permit extensions and other orders of the Department.

Findings of Fact

1. Swalley Irrigation District (District) submitted a Water Management and Conservation Plan (plan) to the Department on January 5, 2011. The plan was required as an update to the District's previously approved plan.
2. The Department published notice of receipt of the plan on January 11, 2011, as required under OAR Chapter 690, Division 086. No comments were received.
3. The Department provided comments on the plan to the District on March 31, 2011 and, in response, the District submitted a revised plan on July 14, 2011.
4. The Department reviewed the revised plan and finds that it is generally consistent with the relevant requirements under OAR Chapter 690, Division 086 (2002).

Conclusion of Law

The Water Management and Conservation Plan submitted by Swalley Irrigation District is consistent with the criteria in OAR Chapter 690, Division 086 (2002).

Now, therefore, it is ORDERED:

1. The Swalley Irrigation District Water Management and Conservation Plan is approved and shall remain in effect until July 19, 2021, unless this approval is rescinded pursuant to OAR 690-086-0920.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

2. Swalley Irrigation District shall submit an updated plan meeting the requirements of OAR Chapter 690, Division 86 (effective November 1, 2002) within 10 years and no later than January 19, 2021.
3. Pursuant to OAR 690-086-0220(3), Swalley Irrigation District shall submit an annual report describing progress-to-date in implementing this water management and conservation plan. This annual report shall be submitted to the Water Resources Department in Salem by January 31 of each year¹.
