Authority

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

Background

- 1. On July 22, 2005, David Setniker filed a transfer application to change the point of diversion and place of use under Certificate 81459. The Department assigned the application number T-9975.
- 2. Efim and Janice Zyryanoff, 12490 Anderson Road, Independence, Oregon 97351 have been designated as receiving landowners.
- 3. The portion of the right to be transferred is as follows:

Certificate: 81459 in the name of DAVE SETNIKER (perfected under Permit S-40168)

Use: IRRIGATION OF 35.5 ACRES

Priority Date: DECEMBER 17, 1975

Rate: 0.44 CUBIC FOOT PER SECOND (cfs), if available at the original point of

diversion described as being located in the SE ¼ NW ¼ as projected within W. Prather DLC 67, Section 35, T. 9 South, R. 4 West, W.M.; 1520 feet

South and 1540 feet East from the NW corner of Section 35.

Limit/Duty: ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent

for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre feet per acre for each acre irrigated during the irrigation

- 6. Notice of the application for transfer was published on August 2, 2005, pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.
- 7. The Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screening and/or by-pass device is necessary at the new point of diversion to prevent fish from entering the diversion and/or safely transport fish back to the body of water from which the fish were diverted and that the diversion is currently equipped with an appropriate fish screening and/or by-pass device.

- 8. On May 2, 2007, the Department mailed to the applicant a copy of the draft Preliminary Determination proposing to approve Transfer Application T-9975, provided the applicant submitted information demonstrating the other recorded owner of the land to be transferred (Joan Setniker) consents to the proposed transfer. On September 27, 2007, the applicant provided a revised application containing Joan Setniker's signature and including her as an applicant, thus satisfying the Department's request. The applicants asked that the Department proceed with issuance of a Preliminary Determination. Necessary information to demonstrate that the applicants are authorized to pursue the transfer was also provided.
- 9. On September 29, 2008, the Department issued a Preliminary Determination proposing to approve Transfer Application T-9975 and mailed a copy to the applicants and receiving landowners. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on September 30, 2008, and in the *Polk County Itemizer-Observer* newspaper on October 8, 15 and 22, 2008, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

Transfer Review Criteria [OAR 690-380-4010(2)]

- 10. Water has been used within the last five years according to the terms and conditions of the rights, and no evidence is available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 11. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing right are present.
- 12. There are portions of three water use permits (G-12474, S-53198 and G-13224) for primary and supplemental irrigation that are appurtenant to the same land from which Certificate 81459 is proposed to be transferred. Because these irrigation permits have later priority dates than Certificate 81459 and there is no deficiency in rate under Certificate 81459, the permits are considered supplemental to Certificate 81459.
- 13. Based upon conversations with the applicant's Certified Water Rights Examiner (Don Knauer), the applicant does not intend to transfer the supplemental water use permits described in Finding No. 11 along with Certificate 81459.
- 14. The proposed changes, as conditioned, would not result in enlargement of the right.
- 15. There are several intervening points of diversion between the existing authorized point of diversion under Certificate 81459 and the proposed new point of diversion. However, the use of water at the proposed new point of diversion can be conditioned to avoid injury to the intervening points of diversion (see proposed Condition No. 5 under the "Determination and Proposed Action" section below).
- 16. The proposed changes, as conditioned, would not result in injury to other water rights.

Partial Cancellation of Supplemental Water Use Permits

- 17. ORS 540.510(1) and OAR 690-380-2250(5) provide that the order approving the transfer of a primary right shall cancel the portion of a supplemental water right or permit appurtenant to the same lands if the supplemental water right or permit is not included in the transfer. Several water use permits that are supplemental to Certificate 81459 are not included in Transfer Application T-9975, and the appurtenant portions of those permits will be cancelled upon issuance of a final order approving T-9975, unless the applicant amends the application to include the supplemental water use permits in the transfer, or to withdraw those lands from the transfer.
- 18. Consistent with OAR 690-380-2250, the Department notified the applicant in the draft Preliminary Determination issued on May 2, 2007, that the Department intended to cancel the portions of the supplemental water use permits described below in Findings #18, #19 and #20, unless within 30 days of the date of the notification the applicant modified the application to include the supplemental water use permits or withdrew the application. The applicant did not provide any modification to include the supplemental rights nor did the applicant withdraw the application.

Conclusions of Law

The changes in place of use and point of diversion proposed in Transfer Application T-9975 are consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000 and the portions of the supplemental water use permits described in Findings #18, #19 and #20, should be cancelled.

Now, therefore, it is ORDERED:

- The changes in place of use and point of diversion proposed in Transfer Application T-9975 are approved.
- The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificate 81459 and any related decree.
- 3. Water right Certificate 81459 is cancelled. A new certificate will be issued describing that portion of the right not affected by this transfer.
- The portions of supplemental water use Permits G-12474, S-53198 and G-13224 described in Findings #18, #19 and #20, are cancelled.

- 5. The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion.
- 6. The former place of use of the transferred right shall no longer receive water under the right.
- 7. The water user shall maintain and operate a fish screening and/or by-pass device, as appropriate, at the point of diversion consistent with the Oregon Department of Fish and Wildlife's operational and maintenance standards.
- 8. When required by the Department, the water user shall install, maintain and operate an in-line flow meters, weirs, or other suitable devices for measuring and recording the quantity of water diverted. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 9. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2010**. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 10. When satisfactory proof of the completed changes is received, a new certificate confirming the right transferred will be issued.
