ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 8071 submitted by

REW RANCHES, INC. 75198 YOAKUM ROAD PENDLETON, OREGON 97801.

The right to be modified, as evidenced by a PORTION of Certificate 54560, was perfected under Permit G-5337 with a date of priority of OCTOBER 21, 1974. The right allows the use of REW WELL 1, in the UMATILLA RIVER BASIN, for IRRIGATION of 13.45 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.13 cubic foot per second, if available at the original well; NW% NE%, SECTION 30, T 3 N, R 31 E, WM; 1070 FEET SOUTH AND 90 FEET EAST FROM THE N1/4 CORNER, SECTION 30, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with the right perfected under Permit G-5335 shall not exceed 2.0 cfs, the capacity of this well system at the time of perfection of this right.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

The applicant proposes to temporarily change the place of use until a permanent transfer is approved. Transfer Application 8070 was filed at the same time as this application.

THIS TEMPORARY CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The change is temporary. The change shall be effective upon issuance of this order.
- 2. The former place of use shall not be irrigated as part of this water right during the term of this order.
- 3. The use shall revert to the authorized place of use at the end of the 2002 irrigation season, or approval of Transfer Application 8070, whichever occurs first.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.

5. The use of the remaining water right described by Certificate 54560 shall continue to be in accordance with the terms and conditions of Certificate 54560.
