Authority

ORS 537.348 establishes the process in which a water right holder may submit a request to lease an existing water right for instream purposes. OAR Chapter 690, Division 077 implements the statutes and provides the Department’s procedures and criteria for evaluating instream lease applications.

Findings of Fact

1. On March 26, 2009 the DRC and NUID, on behalf of various water right holders, filed an application to lease a portion of Certificates 72279 and 72283 to instream use. The Department assigned the application number IL-974.
2. On May 18, 2009, the Department issued an order approving instream lease IL-974, as evidenced by Special Order Volume 77, Page 755. Following issuance of this order a scrivener’s error was identified in the description of the portion of the rights to be leased instream and in identification of when water is protected instream. This order is being issued to correctly describe the portion of certificates 72279 and 72283 leased to instream use and the period during which water is leased instream and supersedes Special Order Volume 77, Page 755. Corrections are shown in bold text in Findings of Fact #3, #4, and #9.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

3. The portion of the first right to be leased is as follows:

5. The lease application includes the information required under OAR 690-077-0076(3). The Department provided notice of the lease application pursuant to OAR 690-077-0077(1). No comments were received in response to that notice.

6. Certificate 72279 includes the diversion of water from two storage facilities, Haystack Reservoir and Wickiup Reservoir, owned by the Bureau of Reclamation (BOR). Pursuant to OAR 690-077-0077 (2)(b), the BOR would need to be a co-lessor on any lease that includes

the use of stored water from either of these reservoirs for instream use. The BOR is not a co-
 lessor to this lease. In Section 2.2 of the lease application, the source of water for the
 proposed lease is described as the Deschutes River. As the BOR is not a co-lessor on this
 lease, the lease of water under certificate 72279 shall be limited to live flow from the
 Deschutes River.

7. The District limits the quantity of water delivered to lands within the district to 1.0 acre-feet per acre (out of 4.0 acre-feet per acre that may be diverted) from the Crooked River and 2.0 acre-feet per acre (out of the 5.25 acre-feet per acre that may be diverted), which is reflected in the maximum volume of water that may be protected instream.
8. The Lessors and Lessee have requested to protect water instream under Certificate 72279 from the POD described in Finding of Fact #2 to the mouth of the Deschutes River. A portion of the water diverted at the POD returns to the Deschutes River within the proposed reach and is available to downstream water right holders. Return flows from the existing use are back in the river system once river flows reach the Madras Gage. To prevent injury to downstream water right holders or enlargement of the right, the quantity of water that may be protected instream requires modification to account for return flows at the Madras Gage.
9. The instream use has been modified to prevent injury or enlargement and is as follows:

Deschutes River, tributary to the Columbia River

Instream Reach #1: From the Deschutes River POD (as described in Finding of Fact #2) to the Madras Gage.

10. Other conditions to prevent injury and enlargement are:

Water leased instream under Certificate 72279 shall be limited to live flow from the Deschutes River.

Within the specified stream reach, the amount of water to which this right is entitled shall not exceed the quantity of water legally available at the original point of diversion. Stream channel losses and gains calculated based on available data and the use of water by senior appropriators will determine the amount of water to which this right is entitled downstream from the original points of diversion within the specified stream reach.

11. If approved, this instream lease is not reasonably expected to significantly affect land use as prescribed by ORS 197.180, OAR Chapter 660, Divisions 30 and 31, and OAR Chapter 690, Division 5.
12. Based upon review of the application, comments received, information provided by the Department's Watermaster, and other available information, the Department finds that the lease will not result in injury or enlargement. This finding is made through an abbreviated review recognizing that the lease may be modified or revoked under OAR 690-077-0077 if the Department later finds that the lease is causing injury to any existing water right or enlargement of the original right.
13. If a right which has been leased is later proposed to be leased again or transferred to an instream use under ORS 537.348 and OAR 690-077-0070 or OAR 690-077-0075 a new injury review shall be required. Transfers will be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 380 and Division 077. Approval of this lease does not establish a precedent for approval of future leases or transfers.
14. The lease will terminate on November 30, 2009.

CONCLUSIONS OF LAW


The Department concludes that the lease will not result in injury or enlargement, OAR 690-077-0077. The lease conforms to the applicable provisions of OAR 690-077-0015.

ORDER

Therefore, it is ORDERED:

1. That the Lease as described herein is APPROVED.
2. The former place of use will no longer receive water as part of these rights, any supplemental rights, or any other layered water rights for irrigation use, including ground water registrations during the term of the lease.
3. This correcting order supersedes Special Order Volume 77, Page 755.
4. The lease will terminate on November 30, 2009.
