# FINDINGS OF FACT

- 1. Pursuant to ORS 540.580, WESTLAND IRRIGATION DISTRICT, P.O. Box 944, Hermiston, OR, 97838, petitioned the Oregon Water Resources Department to permanently change the place of use of water within the boundaries of the irrigation district. The petition was received on December 19, 2002, and included the required fees.
- 2. The Department assigned the petition transfer application number T-9311.
- 3. The Department published notice of receipt of the petition in the Department's Weekly Notice dated January 7, 2003. The petition was noticed as a transfer within irrigation district boundaries.
- 4. No comments or timely protests were received in response to the published notice.
- 5. The following rights are proposed to be modified:
  - a) PRIMARY IRRIGATION

7. On December 19, 2002, the Department received an affidavit from Mary Newman, the owner of lands to which a water right evidenced by Certificate 54736 is appurtenant, requesting a portion of the right be diminished from primary to supplemental irrigation.

The portion of Certificate 54736, perfected under Permit G-6785, requested to be diminished is for the use of 0.15 cubic foot per second from the Ben Newman well for the primary irrigation of 11.7 acres. The date of priority is November 29, 1972. The portion requested to be diminished is described as follows:

The transfer application proposes making the rights evidenced by Certificates 76715 and 76717 primary for the lands described by the portion of Certificate 54736 requested to be diminished. The proposed transfer of primary rights is described in Table 2, Notice #4.

- 8. Pursuant to ORS 540.574 and ORS 540.580, in reviewing the petition submitted by Westland Irrigation District, the Department has determined the following:
  - a) The petition contains the information required under ORS 540.574(3).
  - b) The petition meets the requirements of ORS 540.580.

- c) The petition contains maps which are satisfactory to the Department and which the District certified as being accurate.
- d) The petition includes the required statement from the District that it has on file, and available for review, written authorization from each landowner affected by the transfer.
- e) The rate, duty, and total number of acres proposed for transfer do not exceed that of the water right subject to transfer.
- f) The lands from which the water right would be moved by the proposed transfer will not continue to receive water under the water right.
- g) The use authorized by the water right subject to transfer will not change; and
- g) The proposed change in place of use will not result in injury to other water rights.
- 9. The petition was filed prior to the end of the calendar year or prior to any delivery of water as required under ORS 540.580(2).

### CONCLUSIONS OF LAW

- 1. The petition submitted by Westland Irrigation District proposing permanent changes in place of use within district boundaries included the information, and satisfied the criteria, required by ORS 540.574(3).
- 2. The proposed transfer complies with the requirements of ORS 540.580.
- 3. The Director should approve the transfer because the petition satisfies the criteria and requirements of ORS 540.574(3) and ORS 540.580 resulting in no injury to other water rights.

# **ORDER**

# It is hereby ORDERED:

- 1. The proposed changes to the water right certificates 76715, 76717, 76799 & 79439 may be made provided the following conditions are met by the water user:
  - a. The proposed changes shall be completed on or before October 1, 2005.
  - b. The former places of use shall no longer be irrigated as a part of this water right.

- c. Proof, to the satisfaction of the Director, that the changes approved by this order have been completed must be submitted by Westland Irrigation District, on or before October 1, 2006.
- 2. Except as modified herein, all other conditions and limitations of the Umatilla River Decree remain in effect.
- 3. When the Director determines that it is necessary, or to facilitate records keeping, new certificates will be issued to confirm all completed changes for which satisfactory proof has been made and to confirm that portion of the right not modified by this or any other order.
- 4. The portion of the water right evidenced by Certificate 54736 as described in *Finding of Fact* #7 is diminished from primary to supplemental irrigation.
- 5. Certificate 54736 is canceled. The Department shall issue a new certificate to confirm that portion of the right NOT involved in this transfer, and the diminution of that portion of the right described in *Finding of Fact #7*.
