ORDER APPROVING A CHANGE IN POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6569 submitted by

CROOK COUNTY PARKS & RECREATION DISTRICT 398 N. FAIRVIEW STREET PRINEVILLE, OR 97754

The right to be modified, as evidenced by a portion of Certificate 68395, was perfected under Permit 25991 with a date of priority of APRIL 8, 1914. The right allows the use of THE CROOKED RIVER AND PRINEVILLE RESERVOIR, tributaries of THE DESCHUTES RIVER, for IRRIGATING 13.3 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.17 cubic foot per second, if available at the authorized point of diversion: OCHOCO IRRIGATION DISTRICT MAIN CANAL, SW¼ SE¼, SECTION 36, T 15 S, R 15 E, WM; 60 FEET NORTH AND 1940 FEET WEST FROM THE SE CORNER OF SECTION 36, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acrefeet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

SECTION 8

TOWNSHIP 15 SOUTH, RANGE 16 EAST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes to change the point of diversion to:

NW $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 8, T 15 S, R 16 E, WM; 320 FEET EAST AND 150 FEET SOUTH FROM THE NW CORNER OF SECTION 8.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1997.
- 2. The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water lawfully available at the original point of diversion.
- 3. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same surface water source as the original point of diversion.
