## Authority

ORS 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of appropriation, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

ORS 540.621 establishes the process for the owner of land to which a water right is appurtenant to certify under oath that the water right, or a portion thereof, has been abandoned and to voluntarily request that it be cancelled.

## **Findings of Fact**

## Background

- On July 29, 2009, RIVER-BEND SAND AND GRAVEL CO. filed an application for additional points of appropriation, to change the place of use, and to change the character of use under Certificates 30302 and 83893, and for partial cancellation of Certificates 83034 and 83893. The Department assigned the application number T-10933.
- 2. On February 26, 2010, Ed McGill submitted supporting documents to the affidavit attesting to the use of water.
- 3. The applicant initially proposed to change the character of use to storage for off-season mining and industrial use under Certificate 30302. On April 20, 2010, the agent amended the application to change the character of use to include pond maintenance. The request to

- 13. Certificate 83893 sets an annual duty of 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The annual duty of water for 64.8 acres of equivalent irrigation use would be 162 acre feet (64.8 acres x 2.5 acre-feet per acre) for industrial/manufacturing and mining uses.
- 14. Notice of the application for transfer was published on August 18, 2009, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 15. On September 14, 2011, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-10933 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of October 18, 2011, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 16. On November 28, 2011, the Department issued a Preliminary Determination proposing to approve Transfer Application T-10933 and mailed a copy to the applicant. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on November 29, 2011, and in the Stayton Mail newspaper on January 25, and February 1 and 8, 2012, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notices.

# Transfer Review Criteria (OAR 690-380-4010)

- 17. Water has been used within the last five years according to the terms and conditions of the rights. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 18. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-10933.

- 19. The proposed changes, as conditioned, would not result in enlargement of the rights.
- 20. The proposed changes, as conditioned, would not result in injury to other water rights.

# Partial Cancellation of Certificates 83893 and 83034

- 21. On July 29, 2009, an affidavit certifying that a portion of a water right has been abandoned and requesting cancellation of a portion of the right under Certificate 83893 and 83034 was received from Ed McGill of River-Bend Sand & Gravel Company.

- 23. The affidavit for the partial cancellation of Certificate 83893 lists 0.168 cubic foot per second (cfs) to be cancelled. However, the portion of the right to be cancelled, 13.4 acres, at a rate of diversion of 1/80 cfs per acre, is equal to 0.08 cfs.

#### Conclusions of Law

The additional points of appropriation, change in place of use, and change in character of use proposed in Transfer Application T-10933 are consistent with the requirements of ORS 537.705 and 540.505 to 540.580 and OAR 690-380-5000 and the abandoned rights should be cancelled.

## Now, therefore, it is ORDERED:

- 1. The additional points of appropriation, change in place of use, and change in character of use proposed in Transfer Application T-10933 are approved. The portions of the rights that have been abandoned are cancelled.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 30302, 83034, and 83893 and any related decree.
- 3. Water right certificates 30302, 83034, and 83893 are cancelled. New certificates will be issued describing those portions of the rights not affected by this transfer and cancellation.
- 4. The quantity of water diverted at the additional points of appropriation, together with that diverted at the original points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.

- 5. Water use measurement conditions:
  - a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each point of appropriation.
  - b. The water user shall maintain the meters or measuring devices in good working order.
  - c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice
- 6. Water shall be acquired from the same aquifer (water source) as the original point of appropriation.
- 7. The former place of use of the transferred rights shall no longer receive water under the right.
- 8. The quantity of water allowed for groundwater storage under the right described by Certificate 30302 is limited to an annual duty of 33.5 acre feet between March 1 and October 31 of each year.
- 9. The quantity of water allowed for industrial/manufacturing and mining under the right described by Certificate 83893 is limited to an annual duty of 162 acre feet between March 1 and October 31 of each year.
- 10. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2016**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 11. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
