ORDER APPROVING A CHANGE IN CHARACTER OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7183 submitted by

U.S. FISH AND WILDLIFE SERVICE 911 NE 11TH AVENUE PORTLAND, OREGON 97232-4181.

The first right to be modified, as evidenced by Certificate 37461, was perfected under Permit R-3093 with a date of priority of SEPTEMBER 6, 1962. The right allows the storage of BASKETT SLOUGH, a tributary of RICKREALL CREEK, APPROPRIATED UNDER APPLICATION 38036, PERMIT 28252 IN MORGAN RESERVOIR, for IRRIGATION. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 210.0 acre feet.

The second right to be modified, as evidenced by Certificate 37463, was perfected under Permit R-4520 with a date of priority of DECEMBER 15, 1964. The right allows the storage of BASKETT SLOUGH, a tributary of RICKREALL CREEK, CONSTRUCTED UNDER PERMIT R-3093, APPROPRIATED UNDER APPLICATION 40481, PERMIT 30166 IN MORGAN BROTHERS RESERVOIR (ENLARGEMENT OF RESERVOIR CONSTRUCTED UNDER PERMIT R-3093), for IRRIGATION. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 275.0 acre feet.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

THIS CHANGE TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 2000.

Certificates 37461 and 37463 are cancelled. When satisfactory proof of the completed change is received, new certificates confirming these water rights will be issued.
