IN THE MATTER OF THE CANCELATION OF A WATER RIGHT

On September 1, 1970, George L. and Ross B. Dey submitted an affidavit that they are the legal owners of a water right and the lands to which the right is appurtenant; that they have abandoned any and all interest in and to said water right and request the same to be canceled.

The water right in question is for the use of not to exceed 0.045 cubic foot per second of the waters from Siuslaw River for the irrigation of 3.57 acres in the NW% SW%, Section 14, as projected within Crow DLC 46, Township 20 South, Range 5 West, W.M., with a date of priority of May 6, 1953, and is evidenced by certificate of water right recorded at page 26849, Volume 19, State Record of Water Right Certificates.

That part of the water right evidenced by said certificate for the appropriation of not to exceed 0.585 cubic foot per second of the waters of Siuslaw River for irrigation of:

with a date of priority of May 6, 1953, is not in question.

ORS 540.621 provides: "Whenever the owner of a perfected and developed water right certifies under oath to the State Engineer that the

water right has been abandoned by him and that he desires cancelation thereof, the State Engineer shall enter an order canceling the water right."

NOW, THEREFORE, it hereby is ORDERED that the right for the use of not to exceed 0.045 cubic foot per second of the waters of Siuslaw River for the irrigation of 3.57 acres in the NWM SWM, Section 14, as projected within Crow DLC 46, Township 20 South, Range 5 West, W.M., with a date of priority of May 6, 1953, is canceled.

It is FURTHER ORDERED that the certificate of water right recorded at page 26849, Volume 19, State Record of Water Right Certificates, is canceled, and in lieu thereof a certificate be issued to George L. and Ross B. Dey covering that part of the water right not in question which is for the appropriation of not to exceed 0.585 cubic foot per second of the waters of Siuslaw River, a tributary of Pacific Ocean, with a date of priority of May 6, 1953, for irrigation of:

7.03 acres NW/4 SW/4 as projected within Crow DLC 46 2.8 acres SW/4 SW/4 as projected within Crow DLC 46 Section 14

24.8 acres NEW SEW as projected within Crow DLC 46

1.9 acres NWM SEM as projected within Crow DLC 46

1.5 acres SWA SEWA as projected within Crow DLC 46

2.5 acres SW/4 SE/4

6.0 acres SE% SE% as projected within Crow DLC 46 Section 15
