**ORDER APPROVING CHANGES IN PLACE OF USE
AND POINTS OF APPROPRIATION**

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7372 submitted by

The first right to be modified, as evidenced by a PORTION of Certificate 53232, was perfected under Permit G-9074 with a date of priority of SEPTEMBER 9, 1980. The right allows the use of A WELL, a tributary of the FORT ROCK BASIN, for IRRIGATION OF 5.6 ACRES. The right is limited to 0.07 cubic foot per second, if available at the original well; SE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 4, T 27 S, R 19 E, W.M.; 30 feet NORTH & 1250 feet WEST from the CENTER of SECTION 4, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The authorized place of use is as follows:

The second right to be modified, as evidenced by a PORTION of Certificate 53233, was perfected under Permit G-9075 with a date of priority of SEPTEMBER 9, 1980 for 0.94 cfs and DECEMBER 29, 1980 for 0.20 cfs. The right allows the use of A WELL, a tributary of the FORT ROCK BASIN, for IRRIGATION OF 90.8 ACRES. The right is limited to 1.14 cubic feet per second, if available at the original well; Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$), SECTION 4, T 27 S, R 19 E, W.M.; 1360 feet NORTH and 1320 feet EAST from the C $\frac{1}{4}$ CORNER of SECTION 4, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The authorized place of use is as follows:

The third right to be modified, as evidenced by a PORTION of Certificate 53234, was perfected under Permit G-9076 with a date of priority of SEPTEMBER 9, 1980 for 1.65 cfs and DECEMBER 29, 1980 for 0.05 cfs. The right allows the use of A WELL, a tributary of the FORT ROCK BASIN, for IRRIGATION OF 136.0 ACRES. The right is limited to 1.70 cubic feet per second, if available at the original well; SE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 4, T 27 S, R 19 E, W.M.; 1320 feet SOUTH & 1300 feet WEST from the CENTER $\frac{1}{4}$ CORNER of SECTION 4, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

0.07 cubic foot per second - priority date SEPTEMBER 17, 1980 and 0.002 cubic foot per second - priority date DECEMBER 29, 1980 to: SE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 12, T 27 S, R 16 E, W.M.; 1325 feet SOUTH and 1349 feet EAST from WEST $\frac{1}{4}$ CORNER of SECTION 12;

1.58 cubic feet per second - priority date SEPTEMBER 17, 1980 and 0.048 cubic foot per second - priority date DECEMBER 29, 1980 to: SE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 20, T 27 S, R 16 E, W.M.; 1310 feet NORTH and 1330 feet EAST from the SW CORNER of SECTION 20.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.


THESE CHANGES TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed changes shall be completed on or before October 1, 2000.
2. The quantity of water diverted at the new points of appropriation (wells), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water available from the original points of appropriation.

3. When required by the Department the water user shall install in-line flow meters or other suitable devices for measuring and recording the quantity of water used. The type and plans of the measuring devices must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original points of appropriation.
5. The former places of use shall no longer be irrigated as part of these water rights.

Certificates 53232, 53233 and 53234 are canceled. When satisfactory proof of the completed change is received, new certificates confirming this water right will be issued.
