## **Authority**

ORS 540.505 to 540.580 establish the process in which a water right holder may submit a request to temporarily transfer the place of use and, if necessary to convey the water to the temporary place of use, the point of diversion authorized under an existing water right.

OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

### **Findings of Fact**

- 1. On April 16, 2013, HALE FARMS LLC, filed an application to temporarily change the places of use and change the points of diversion to serve the proposed places of use under Certificates 79482 and 87111 for a period of one year. The Department assigned the application number T-11573.
- 2. The portion of the first right to be temporarily transferred is as follows:

Certificate: 79482 in the name of POTLATCH CORP. (perfected under Permit S-36940)

Use: IRRIGATION of 256.4 ACRES

Priority Date: JUNE 29, 1973

**Rate:** 6.34 CUBIC FEET PER SECOND (cfs)

Limit/Duty: The amount of water used for irrigation, together with the amount secured

under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cfs, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre

for each acre irrigated during the irrigation season of each year.

Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Rate: 2.77 CUBIC FEET PER SECOND (cfs), being 2.18 cfs priority October 3,

1973 plus one minute and 0.59 cfs priority December 11, 1973 plus one

minute

Limit/Duty: The amount of water used for irrigation, together with the amount secured

under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cfs, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre

for each acre irrigated during the irrigation season of each year.

7. A change in point of diversion is necessary to convey the water to the proposed temporary place of use. Temporary Transfer Application T-11573 proposes to move the authorized point of diversion approximately 29.5 miles downstream to:

- 8. Notice of the application for transfer was published on April 23, 2013, pursuant to OAR 690-380-4000. Due to a typographical omission, Temporary Transfer T-11573 was renoticed pursuant to OAR 690-380-4000 on April 30, 2013. No comments were filed in response to either of the notices.
- 9. Water use Permits S-54675 and S-51017 are appurtenant to a portion of the lands identified in Finding of Fact #3, the proposed place of use for a portion of Certificate 79482. These water use permits, due to rate restriction and scheduled crop rotations, will not be used during the term of this temporary transfer.
- 10. Portions of water use Permit S-54561 are appurtenant to portions of the proposed place of use described in Finding of Fact #6. Water use Permit S-54561 will not be exercised on these lands for the term of this temporary transfer.

#### Temporary Transfer Review Criteria

- 11. Water has been used within the last five years according to the terms and conditions of the rights. There is no evidence available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 12. Diversion structures and pumps, pipelines, and sprinkler systems sufficient to use the full amount of water allowed under the existing rights are present.
- 13. The proposed changes would not result in enlargement of the rights.
- 14. The proposed changes would not result in injury to other water rights. This finding is made through an abbreviated review recognizing that the transfer may be revoked under ORS 540.523(5) if the Department later finds that the transfer is causing injury to any existing water right.

#### **Conclusions of Law**

The temporary changes in place of use and point of diversion proposed in Temporary Transfer Application T-11573 are consistent with the requirements of ORS 540.523 and OAR 690-380-8000.

#### Now, therefore, it is ORDERED:

- 1. The temporary changes in place of use and points of diversion proposed in Temporary Transfer Application T-11573 are approved.
- 2. The former place of use **shall not** be irrigated as part of these water rights during the 2013 irrigation season.
- 3. The use shall revert to the authorized place of use at the end of the 2013 irrigation season. The authorization to use the temporary points of diversion shall be terminated concurrently.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the changes cause injury to any existing water right.
- 5. A subsequent application for permanent transfer of Certificates 79482 and 87111 shall be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 380. Approval of this temporary transfer does not establish a precedent for approval of a subsequent application filed for a permanent transfer.
- 6. The use of water at the temporary place of use authorized by this transfer shall be in accordance with the terms and conditions of Certificates 79482 and 87111.
- 7. The time during which water is used under this approved temporary transfer does not apply toward a finding of forfeiture under ORS 540.610.
- 8. The water user shall maintain and operate the existing measurement devices and shall make such improvements as may be required by the Department.
- 9. The use of the remaining portions of the water rights described by Certificates 79482 and 87111 shall continue to be in accordance with the terms and conditions of Certificates 79482 and 87111.
