ORDER APPROVING A CHANGE IN POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7608 submitted by

LISA MCKAY 19393 FRENCH PRAIRIE ROAD ST. PAUL, OREGON 97137.

The right to be modified, as evidenced by a PORTION of Certificate 60723, was perfected under Permit G-8635 with a date of priority of AUGUST 14, 1979. The right allows the use of A WELL, in the LITTLE PUDDING RIVER BASIN, for IRRIGATION OF 69.3 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.86 cubic foot per second, if available at the original well; LOT 1 (NE% NW%), SECTION 9, T 6 S, R 2 W, WM; 1250 FEET SOUTH AND 1990 FEET EAST FROM THE NW CORNER, SECTION 9, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

LOT 5 (SE% SW%) 1.9 ACRES
SE% SW% 3.2 ACRES
SW% SE% 16.9 ACRES
SE% SE% 2.5 ACRES
all as projected within DLC 59
SECTION 4

NW¼ NE¼ 15.8 ACRES as projected within DLC 59 LOT 1 (NW% NE%) 1.0 ACRE NW¼ NE¼ 0.6 ACRE as projected within DLC 60 NE¼ NW¼ 4.6 ACRES as projected within DLC 59 LOT 1 (NE% NW%) 22.8 ACRES SECTION 9 TOWNSHIP 6 SOUTH, RANGE 2 WEST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the point of appropriation

SW% SE%, as projected within DLC 59, SECTION 4, T 6 S, R 2 W, WM; 450 FEET NORTH AND 3350 FEET EAST FROM THE SW CORNER, SECTION 4.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1998.
- The quantity of water diverted at the new point of 2. appropriation (well), together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.
- 3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- Water shall be acquired from the same aquifer as the 4. original point of appropriation.

Certificate 60723 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
