Authority

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

Background

- 1. On June 5, 2009, Baker Valley Irrigation District filed an application to change the points of diversion and to change the place of use under Certificates 73587, 73610, 73999 and 80460. The Department assigned the application number T-10897.
- 2. The portion of the first right to be transferred is as follows:

Certificate: 73587 in the name of Thomas and Karen Rudolph (confirmed by Powder

River Decree)

Use: IRRIGATION OF 13.8 ACRES

Priority Date: 1906

Rate: 0.345 CUBIC FOOT PER SECOND

Limit/Duty: The amount of water used for irrigation, together with the amount secured

under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second for each acre irrigated during

the irrigation season of each year.

- 14. There is an underlying groundwater Permit G-16347 (Application G-16941) that is within the place of use listed under Finding of Fact Number 11. The application requested that the permit be issued for Primary Irrigation Use. The use was diminished to Supplemental Irrigation until such time that the transfer of the conflicting surface water right is approved. The claim of beneficial use report for permit G-16347 can then be proved up as Primary Irrigation Use after the surface water right is transferred.
- 15. Notice of the application for transfer was published on June 30, 2009, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 16. On October 23, 2009, the Department mailed a copy of the Preliminary Determination proposing to approve Transfer Application T-10897 to the applicant and agent. The Preliminary Determination cover letter set forth a deadline of November 23, 2009, for the applicant/agent to respond. On November 9, 2009 the agent requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 17. On November 23, 2009, the Department issued a Preliminary Determination proposing to approve Transfer Application T- 10897 and mailed a copy to the applicant and agent. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on December 1, 2009, and in the Record-Courier newspaper on November 26, December 3, and 10, 2009, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.

18. The Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screening and/or by-pass device may be required in the future at the new point of diversion to prevent fish from entering the diversion and/or safely transport fish back to the body of water from which the fish were diverted and that the diversion is not currently equipped with an appropriate fish screening and/or by-pass device.

Transfer Review Criteria [OAR 690-380-4010 (2)]

- 19. Water has been used within the last five years according to the terms and conditions of the rights. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 20. Diversion structure and ditches sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-10897.
- 21. The proposed change(s) would not result in enlargement of the rights.
- 22. The proposed change(s) would not result in injury to other water rights.

Conclusions of Law

The change in points of diversion and changes in place of use proposed in Transfer Application T-10897 are consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000.

Now, therefore, it is ORDERED:

- 1. The changes in points of diversion and places of use proposed in Transfer Application T-10897 are approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 73587, 73610, 73999, 80460, and any related decree.
- 3. Water Right Certificates 73587 and 80460 are cancelled. New certificates will be issued describing those portions of the rights not affected by this transfer.
- 4. Water Right Certificates 73610 and 73999 are modified. The Department will issue superseding certificates describing the rights when the Department determines that new certificates are necessary for record keeping.
- 5. The quantity of water diverted at the new points of diversion shall not exceed the quantity of water lawfully available at the original points of diversion.
- 6. The existing measurement device shall be maintained in operable condition.

- 7. The existing headgate shall be maintained and such improvements shall be made should they be required by the Department.
- 8. Within one year after receiving written notification from the Oregon Department of Fish and Wildlife (ODFW) that a fish screening and/or by-pass device is required, the water user shall install a screening and/or by-pass device, as appropriate, at the new point of diversion. The fish screening and/or by-pass device must meet ODFW's design and construction standards. Prior to installation, the water user shall obtain written approval from ODFW that the required screening and/or by-pass device meets ODFW's criteria. Once installed the water user shall maintain and operate the fish screening and/or by-pass device, as appropriate, at the point of diversion consistent with ODFW's operational and maintenance standards.
- 9. The former place of use of the transferred rights shall no longer receive water under the rights.
- 10. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2011**. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 11. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
