20. The District permanent transfer application satisfies the criteria of OAR 690-385-4000, contains the information required under OAR 690-385-2000, and includes maps meeting the requirements of OAR 690-385-2200.
21. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
22. The proposed change in place of use would not result in enlargement of the rights.

23. The proposed change in place of use will not result in injury to other water rights.


Conclusions of Law

The change in place of use proposed in Transfer Application T-11501 satisfies the requirements of ORS 540.574(3) and 540.580

Now, therefore, it is ORDERED:

1. The proposed change to the water rights evidenced by Certificates 85288, 85876, 85877, 80575, 80576, 80577 and 83729 are approved.
2. The right to the use of water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificates 85288, 85714, 80575, 80576, 80577, 83729, 85876 and 85877, and any related decree.
3. The former places of use shall no longer be irrigated as part of these water rights.
4. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before October 1, 2015. A Claim of Beneficial Use shall be submitted to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
5. Certificates 85288, 85714, 80575, 80576, 80577, 83729, 85876, and 85877 are modified. The Department will issue superseding certificates describing the rights when it determines that is necessary for record keeping.
