## ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.523, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 7810 submitted by

LARSON SKYLINE FARM
4395 HEINZE BOULEVARD
ONTARIO, OREGON 97914.

The right to be modified, as evidenced by a portion of Certificate 74020, was perfected under Permit 31231 with a date of priority of JUNE 27, 1966. The right allows the use of the SNAKE RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 258.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 5.27 cubic foot per second, if available at the authorized point of diversion: LOT 1 (NE% NW%), SECTION 21, T 17 S, R 47 E, WM; 350 FEET SOUTH AND 1980 FEET EAST FROM THE NW CORNER, SECTION 21, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acrefeet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

- 1. The change is temporary. The change shall be effective upon issuance of this order.
- 2. The former place of use shall not be irrigated as a part of this water right during the 1997 irrigation season.
- 3. The use shall revert to the authorized place of use at the end of the 1997 irrigation season.
- 4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
- 5. The use of the remaining water right described by Certificate 74020 shall continue to be in accordance with the terms and conditions of Certificate 74020.
