O R D E R

APPROVING APPLICATION

On December 23, 1960, Pacific Power and Light Company of Portland, Oregon, filed an application in the office of the State Engineer for the approval of a change in point of diversion of water from a well, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to Pacific Power and Light Company and recorded at page 22868, Volume 16, State Record of Water Right Certificates, confirms a right under Permit No. U-372 for the use of 1.1 cubic feet per second of water from a well located in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 5, Township 15 South, Range 16 East, W. M., for municipal use in the N $\frac{1}{2}$  NE $\frac{1}{4}$  and SE $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 6 and W $\frac{1}{2}$  NE $\frac{1}{4}$  and NW $\frac{1}{4}$  of Section 5, Township 15 South, Range 16 East, W. M., and the SE $\frac{1}{4}$  of Section 31 and the SW $\frac{1}{4}$  and W $\frac{1}{2}$  SE $\frac{1}{4}$  of Section 32, Township 14 South, Range 16 East, W. M., with a date of priority of December 8, 1950. The point of diversion is located 350 feet north and 450 feet east from the W $\frac{1}{2}$  corner of Section 5, being within the SW $\frac{1}{4}$  NW $\frac{1}{4}$  of Section 5, Township 15 South, Range 16 East, W. M.

The applicants herein propose to change the point of diversion to a well to be located 375 feet north and 370 feet east from the W $\frac{1}{2}$  corner of Section 5 and being within the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 5, Township 15 South, Range 16 East, W. M.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason said section provides notice is not required on an application for a change in point of diversion of water of less than one-fourth mile where there are no intervening diversions.

Mr. Jack E. Sceva, Geologist from the office of the State Engineer, has filed a report to the effect that the proposed change in point of diversion of water may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion of water may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in point of diversion of water from a well, to-wit:

From a point located 350 feet north and 450 feet east from the  $W\frac{1}{2}$  corner of Section 5, being within the  $SW\frac{1}{2} NW\frac{1}{2}$ , Section 5, Township 15 South, Range 16 East, W. M.


To a point to be located 375 feet north and 370 feet east from the  $W\frac{1}{2}$  corner of Section 5 and being within the  $SW\frac{1}{2} NW\frac{1}{2}$ , Section 5, Township 15 South, Range 16 East, W. M.,

for municipal use in the  $N\frac{1}{2} NE\frac{1}{2}$  and  $SE\frac{1}{2} NE\frac{1}{2}$  of Section 6 and  $W\frac{1}{2} NE\frac{1}{2}$  and  $NW\frac{1}{2}$  of Section 5, Township 15 South, Range 16 East, W. M., and the  $SE\frac{1}{2}$  of Section 31 and the  $SW\frac{1}{2}$  and  $W\frac{1}{2} SE\frac{1}{2}$  of Section 32, Township 14 South, Range 16 East, W. M., with a date of priority of December 8, 1950, be and the same is approved.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1961, or within such extension of time as may be granted by the State Engineer for good cause shown.
