ORS 540.570 establishes the process in which a district may submit a request to temporarily transfer a water right within district boundaries. OAR Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

## Findings of Fact

- 1. Stanfield Irrigation District filed a district transfer application to temporarily change the place of use under Certificates 79442 and 79440. The Department assigned the application number T-9867.
- 2. Notice of the application for transfer was published pursuant to ORS 540.570 and OAR 690-385-3400. No comments have been filed in response to the notice.
- 3. The portion of the first right to be transferred is as follows:

Certificate 79442: issued in the name of Stanfield Irrigation District

Use: Irrigation, Domestic and Stock Water

Acres: 101.42

Source: Umatilla River, tributary to Columbia River

**Priority Date:** March 8, 1905

Rate & Duty: Maximum of 1/80 cfs per acre March 1 to November 1 and subject to the

limitations of paragraph 32 of the Umatilla River Decree for each acre

irrigated during the irrigation season of each year.

- 7. The district temporary transfer application satisfies the criteria of OAR 690-385-3000, contains the information required under OAR 690-385-2000, and includes maps meeting the requirements of OAR 690-385-2200.
- 8. The water right is subject to transfer as defined in OAR 690-385-0100(17).
- 9. The proposed change in place of use would not result in enlargement of the right.

10. The proposed changes would not result in injury to other water rights.

#### **Conclusions of Law**

The proposed changes in application T-9867 satisfy the requirements of ORS 540.574(3) and 540.570.

## Now, therefore, it is ORDERED:

- 1. The proposed changes to the water rights evidenced by Certificates 79442 and 79440 are approved.
- 2. The temporary transfer is effective for the 2005 irrigation season.
- 3. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificates 79442 and 79440 and any related decree.
- 4. The use of water on the lands from which the water right is transferred and at the new temporary place of use during the same irrigation season or calendar year is prohibited and may subject the district and landowner to civil penalties.
- 5. The use of water under this temporary transfer may be conditioned or revoked at any time to the extent necessary to avoid injury if the Department finds the transfer causes injury to any existing water right.
- 6. At the end of the 2005 irrigation season all uses of water under this temporary transfer revert automatically to the terms and conditions of the original water right permit, certificate, or adjudication as evidenced by a court decree.
- 7. When required by the Department, the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
