ORDER APPROVING AN ADDITIONAL POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8241 submitted by

BILL BOTELHO P.O. BOX 45 SMITH, NEVADA 89430

The right to be modified, as evidenced by Certificate 75601, was perfected under Permit G-9165 with a date of priority of NOVEMBER 20, 1980. The right allows the use of A WELL, in the GOOSE LAKE BASIN, for IRRIGATION OF 440.1 ACRES: BEING 102.6 ACRES PRIMARY AND 337.5 ACRES SUPPLEMENTAL. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 5.41 cubic foot per second, if available at the original well; SW¼ SE¼, SECTION 30, T 38 S, R 20 E, W.M.; 1240 FEET NORTH and 2620 FEET WEST from the SE CORNER of SECTION 30, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, provided further that the amount of water rediverted from the channel of THOMAS CREEK shall not exceed the amount by which the flow of THOMAS CREEK is increased above the natural flow by the operation of the well.

NOTICE: Under the provisions of OAR 137-004-0080, the applicant may petition for reconsideration of this order. The petition shall set forth specific grounds for reconsideration. The petition for reconsideration must be filed within 60 days after the date this order is served.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

The user shall install and maintain a weir, meter or other suitable measuring device and shall keep a complete record of the amount of ground water withdrawn.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to add a new point of appropriation in the:

SE1/4 NW1/4, SECTION 31, T 38 S, R 20 E, W.M.; 1400 FEET SOUTH and 2440 FEET EAST from the NW CORNER, SECTION 31.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- The proposed change shall be completed on or before October 1, 2000. 1.
- The quantity of water diverted at the new point of appropriation (well), together with the 2. quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.
- The water user shall install an in-line flow meter or other suitable device for measuring 3. and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- Water shall be acquired from the same aquifer as the original point of appropriation. 4.

Certificate 75601 is canceled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
