**Authority**

Oregon Revised Statute (ORS) 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of appropriation, place of use, or character of use authorized under an existing water right. Oregon Administrative Rule (OAR) Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

ORS 540.621 establishes the process for the owner of land to which a water right is appurtenant to certify under oath that the water right, or a portion thereof, has been abandoned and to voluntarily request that it be cancelled.

**Findings of Fact**

1. On February 24, 2015, TIM WARKENTIN filed an application for an additional point of appropriation, to change the point of appropriation, to change the place of use, and to cancel a portion of a water right under Certificates 53454, 64043, 75740, 86890, and 86891. The Department assigned the application number T-11989.
2. Notice of the application for transfer was published on March 3, 2015, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
3. On February 24, 2015 an affidavit was received from Jamey and Amber Warkentin and Tim and Paulette Warkentin to cancel a portion of a water right to make up for the deficiency in rate.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

4. On September 28, 2015 the applicant submitted a revised map clarifying the acres being transferred.
5. On October 26, 2015 the applicant submitted a revised map clarifying the acres being transferred.
6. On December 17, 2015, the Department sent a copy of the draft Preliminary Determination proposing to approve Transfer Application T-11989 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of January 18, 2015, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
7. On January 13, 2016, the Department issued a Preliminary Determination proposing to approve Transfer Application T-11989 and sent a copy to the applicant. Additionally, notice of the Preliminary Determination for the transfer application was published in the Department's weekly notice on January 13, 2016, and in the Lake County Examiner newspaper on January 20 and 27, 2016, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.
8. The first right to be transferred is as follows:

**Limit/Duty:** The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that in the event of a request for a change in point of appropriation, an additional point of appropriation or repair of this well, the quantity of water allowed herein together with any other right from this point of appropriation shall not exceed the capacity of this well at the time of perfection of this right..

**Transfer Review Criteria (OAR 690-380-4010)**

- 23. Water has been used within the last five years according to the terms and conditions of the rights. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 24. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-11989.
- 25. The proposed changes would not result in enlargement of the rights
- 26. The proposed changes would not result in injury to other water rights.
- 27. All other application requirements are met.

**Partial Cancellation of a Water Right**

28. On February 24, 2015 an affidavit was received cancelling a portion of acres from Certificate 75740 to make up for a deficiency of rate. The affidavit was received from Jamey and Amber Warkentin and Tim and Paulette Warkentin. The result of this cancellation will bring the water right up to one-eightieth of one cubic foot per second, not to exceed 0.67 cubic foot per second for 53.6 acres. The acres to be cancelled are as follows:

## Conclusions of Law


The additional point of appropriation, change in point of appropriation and change in place of use proposed in Transfer Application T-11989 are consistent with the requirements of ORS 537.705 and 540.505 to 540.580 and OAR 690-380-5000 and the requested right is cancelled.

### Now, therefore, it is ORDERED:

1. The additional point of appropriation, change in point of appropriation, and change in place of use proposed in Transfer Application T-11989 are approved. The portion of the right requested to be cancelled is cancelled.
2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 53454, 64043, 75740, 86890 and 86891, and any related decree.
3. Water right Certificates 53454, 64043, 75740, 86890, and 86891 are cancelled. New certificates will be issued describing those portions Certificates 86890 and 86891 not affected by this order.
4. The quantity of water diverted at the new or additional points of appropriation, together with that diverted at the original points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.
5. Water use measurement conditions:
  - a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device at each point of appropriation (new and existing).
  - b. The water user shall maintain the meters or measuring devices in good working order.
  - c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices is/are located within a private structure, the Watermaster shall request access upon reasonable notice.
6. Water shall be acquired from the same aquifer (water source) as the original points of appropriation.
7. The former place of use of the transferred rights shall no longer receive water under the rights.
8. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2017**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.

9. After satisfactory proof of beneficial use is received, new certificates confirming the rights transferred will be issued.
