## Authority

ORS 540.621 directs the Commission to enter an order canceling a water right whenever the owner of a perfected and developed water right certifies under oath to the Commission that the water right has been abandoned and the owner desires to cancel the right.

## Findings of Fact

1. On May 4, 2011, the Department issued an order cancelling 0.33 acre of Certificates 83571 and 76714. The order was recorded at Special Order Volume 84, Pages 94-96.
2. The order contains a scrivener's error in the quantity by which Certificate 83571, at point of diversion \#1, would be reduced. The incorrect quantities listed in the cancellation order were:

## Now, therefore, it is ORDERED:

1. The order cancelling 0.33 acre of Certificates 83571 and 76714 , recorded at Special Order Volume 84, Pages $94-96$, is amended to correctly describe the amount by which Certificate 83571 is reduced, at point of diversion \#1, as listed in Finding of Fact \#3.
2. All other provisions of the order are unchanged.
