ORDER APPROVING
TRANSFER NO. 4600

On September 10, 1980, an application was filed in the office of the Water Resources Director by Paul T. Gorin for approval of a change in use heretofore made of water from a well, pursuant to the provisions of ORS 537.705.

The certificate recorded at page 44454, Volume 36, State Record of Water Right Certificates, in the name of Paul T. Gorin, describes a right for the use of not to exceed 0.4 cubic foot per second from from a well, under a priority date of January 24, 1967, for irrigation of a certain 19.5 acres in SW 1/4 NW 1/4, 26.4 acres in NW 1/4 SW 1/4, both as projected within Garner T. Foster DLC 49, Section 19, Township 4 North, Range 1 West, W.M.; 14.2 acres in SE 1/4 NE 1/4 and 15.3 acres in NE 1/4 SE 1/4, both as projected within Garner T. Foster DLC 42, Section 24, Township 4 North, Range 2 West, W.M.

The authorized point of appropriation is located 180 feet North and 860 feet East from the Southwest Corner of Foster DLC 42, being within the SW 1/4 NW 1/4, Section 19, Township 4 North, Range 1 West, W.M.

The applicant proposes to change the use heretofore made to group domestic use in the Warren Water Association service area, located within Sections 18, 19 and 30, Township 4 North, Range 1 West, and Sections 13, 23, 24, 25 and 26, Township 4 North, Range 2 West, W.M.

Notice of the application, pursuant to ORS 540.520(2), was published in the Sentinel-Mist Chronicle, a newspaper printed and having general circulation in Columbia County, Oregon, for a period of three weeks in the issues of September 25, October 2 and 9, 1980.

Mr. Clayton J. Gardner, Watermaster, has filed a statement to the effect that the proposed change in use heretofore made may be made without injury to existing rights.


No objections having been filed and it appearing that the proposed change in use heretofore made may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in use heretofore made, as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1982.

It is FURTHER ORDERED that the certificate recorded at page 44454, Volume 36, State Record of Water Right Certificates, is canceled; and in lieu thereof a new certificate be issued covering the balance of the right NOT involved in this proceeding; and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to Warren Water Association.
