**ORDER APPROVING A CHANGE IN PLACE OF USE  
AND POINT OF APPROPRIATION**

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8045 submitted by

FLOWERREE FARMS INC.

The right to be modified, as evidenced by a PORTION of Certificate 57229, was perfected under Permit G-9020 with a date of priority of JUNE 11, 1980. The right allows the use of WELL 1, a tributary of the FORT ROCK BASIN, for IRRIGATION of 125.0 ACRES. The right is limited to 1.56 cubic feet per second, if available at the original well; NW¼ NW¼, SECTION 8, T 27 S, R 19 E, W.M.; 1340 feet NORTH and 1320 feet WEST from the CENTER ¼ CORNER, SECTION 8, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

NE¼ NW¼ 33.4 ACRES  
NW¼ NW¼ 32.3 ACRES  
SW¼ NW¼ 32.7 ACRES  
SE¼ NW¼ 26.6 ACRES

SECTION 8  
TOWNSHIP 27 SOUTH, RANGE 19 EAST W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the place of use to:

NE $\frac{1}{4}$  NW $\frac{1}{4}$  31.3 ACRES  
NW $\frac{1}{4}$  NW $\frac{1}{4}$  31.2 ACRES  
SW $\frac{1}{4}$  NW $\frac{1}{4}$  31.2 ACRES  
SE $\frac{1}{4}$  NW $\frac{1}{4}$  31.3 ACRES

SECTION 6  
TOWNSHIP 27 SOUTH, RANGE 19 EAST W.M.

The applicant proposes to change the point of appropriation to: NE $\frac{1}{4}$  NW $\frac{1}{4}$ , SECTION 6, T 27 S, R 19 E, W.M.; 120 feet WEST and 20 feet SOUTH from the NORTH  $\frac{1}{4}$  CORNER, SECTION 6.


The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 2000.
2. The quantity of water diverted at the new point of appropriation (well),, together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water available from the original point of appropriation.
3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.
5. The former place of use shall no longer be irrigated as part of this water right.

Certificate 57229 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
