ORDER APPROVING A CHANGE IN POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.531, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7527 submitted by

The right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County as evidenced by a PORTION of Certificate 55602. The decree is recorded in the Order Record of the Water Resources Director in Volume 3, at Page 127. The date of priority is SEPTEMBER 11, 1894.

The right allows the use of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for MUNICIPAL AND DOMESTIC SUPPLY FOR THE CITY OF STANFIELD, OREGON. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 11.58 cubic feet per second, if available at the authorized point of diversion: SE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 8, T 3 N, R 29 E, WM; DILLON DIVERSION DAM - 2340 FEET SOUTH AND 2900 FEET WEST FROM THE NORTHEAST CORNER, SECTION 8, or its equivalent in case of rotation, measured at the point of diversion from the source.

Under the provisions of OAR 137-004-0080, the applicant may petition for reconsideration of this order. The petition shall set forth specific grounds for reconsideration. the petition for reconsideration must be filed within 60 days after the date this order is served.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

The applicant proposes to change the point of diversion to a shallow hydraulically connected well, located as follows:

NW $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 31, T 4 N, R 29 E, WM; 1720 FEET NORTH AND 2320 FEET WEST FROM THE SOUTHEAST CORNER, SECTION 31.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 2004.
