## **Findings of Fact**

- 1. On March 22, 2012, the Department issued an order approving Transfer Application T-11168. The order was recorded at Special Order Volume 87, Pages 233 238.
- 2. The order limited the quantity of water, at points of diversion #1 and #11, involved in the transfer. Those quantities contained a scrivener's error. The *erroneous quantities* are described in the tables below:
